

**Asheville-Buncombe Air Quality Agency**  
**Petition for Exemption**  
**from 40 CFR Part § 63.11169 – 63.11180, Subpart HHHHHH**  
**for the Surface Coating for Motor Vehicles and Mobile Equipment**

---

Owners or operators of businesses that paint motor vehicles or mobile equipment may petition the Asheville-Buncombe Air Quality Agency (AB Air Quality) and the US Environmental Protection Agency for an exemption from this rule if they can show that they **do not spray apply** any coatings that as mixed contain any of the following target Hazardous Air Pollutants (HAPs).

- **chromium** (Cr)
- **manganese** (Mn)
- **nickel** (Ni)
- **cadmium** (Cd)
- **lead** (Pb)

To apply for the exemption you must provide the following information.

Please be advised that you could be requested by AB Air Quality to supply a material safety data sheet (MSDS) for each of your coatings to support this Petition for Exemption.
