

**BUNCOMBE COUNTY BOARD OF ELECTIONS
MINUTES OF NOVEMBER 10, 2014**

THE BUNCOMBE COUNTY BOARD OF ELECTIONS MET ON NOVEMBER 10, 2014 AT 8:30 A.M., AT 35 WOODFIN STREET, MEETING ROOM #330, IN ASHEVILLE NORTH CAROLINA, WHERE AND WHEN THE FOLLOWING BUSINESS WAS TRANSACTED:

The meeting was called to order at 8:30 a.m. The Board reviewed 32 absentee ballots with no postmark. The ballots were received between November 4th and November 7th. The State Board of Elections has advised staff that ballots with no postmark received after Election Day cannot be counted. Member Smith motioned to disapprove the 32 ballots, Secretary Knapp seconded and the motion passed unanimously.

The Board reviewed 5 absentee ballots with voter's signatures that appeared different than what is in the voter's record in our database. The Board also reviewed 15 absentee ballots that were missing the voter's signature on the absentee return envelope. Chairman Watson entertained a motion to disapprove the 5 ballots with different signatures and the 15 ballots with missing signatures. Secretary Knapp moved to disapprove the ballots. Member Smith seconded and the motion passed unanimously.

Rachel Rathbone presented to the Board 110 absentee ballots with incomplete witness information. Director Parker reminded Rachel that the Board had to review the incomplete applications and formally vote on them. Director Parker stated that this was not a staff function. The 110 absentee ballots were disapproved unanimously by the Board.

The Board reviewed 5 absentee ballots which were postmarked after 5 p.m. on Election Day. The Board voted unanimously to disapprove the 5 absentee ballots pursuant to G.S. 163-231.

Rachel Rathbone presented 273 civilian absentee ballots, 14 overseas absentee ballots, and 3 military absentee ballots to the Board. (Attached) All presented ballots were approved unanimously by the Board. The staff scanned the mailed absentee ballots in the 650 scanner. Ten ballots could not be read by the 650 scanner so a hand-eye count


was conducted by a bi-partisan team. The team also duplicated 17 absentee ballots that were returned via e-mail and cannot be read by the 650 scanner.


The Board approved the minutes from the November 1st and November 4th board meetings.

Director Parker stated that she has received request for data from Christina Merrill. She added that a majority of the information Ms. Merrill is requesting cannot be provided until Canvass is complete on Friday. The Board unanimously instructed Director Parker to concentrate on preparing for Canvass and to inform Ms. Merrill that the information she is requesting will be provided to her once Canvass is complete and staff has time to accommodate her request.

The Board unanimously approved the supplemental absentee abstract and the results were sent to the State Board of Elections.

The meeting adjourned at 11:10 a.m.
