The director presented minutes for October 31<sup>st</sup> and Election Day. George Keller moved to approve and Lucy Smith seconded that the minutes be approved as amended.

The director explained that a decision needed to be made as soon as possible regarding the March election's early voting sites. The group decided to meet on November 16<sup>th</sup> at 5:30 p.m.

The meeting adjourned at 11:00 a.m.


