# Narrative summary of grant related activities

Quarter 1	We hired a contractor to work 25 hours a week as a community health worker. He got trained in violence prevention. We secured 100% FTE for Executive Director salary, as a contractor for Land of Sky Regional Council. We brought on a Finance Director and we are implementing Apricot Essentials for case management, tracking, and grant reporting. It has been challenging to keep up with the spreadsheet. It has been challenging in community because everyone is starting to refer people to us and we do not have the capacity to properly serve them all. We are working closely with partnering organizations: NC Works, Mountain Area Workforce Development Board, Vocational Rehabilitation, VAYA Health, and United Way. We are seeing that there is a need for a residential reentry program that is culturally responsive to the needs of Black Asheville.
Quarter 2	We have started to use the Apricot Software for enrollments. We are still working closely with Land of Sky Regional Council and Southwestern Commission, getting our members connected for dislocated worker services. We currently have three that are working for a company called Solfarm and they have On-the-Job Training contracts in which the Workforce Board reimburses the employer 75% of the salary for 6 months. We are brining one of our members on as a paid, technical intern, paid for by Vocational Rehabilitation. We are on track to meet our goals.
Quarter 3	We have fully implemented the Apricot system. We have updated our referral process and our referral partners. We continue to collaborate with regional partners to connect our target population to necessary resources for successful reentry. We connect all program participants to recovery group opportunities within the community. We are offering our staff numerous trainings to enhance their skills to support the mission.
