Easement Project Presentations: Ariel Zijp introduced the newest Board Member, Chase Hubbard, to other Board Members, who also all briefly introduced themselves. Ms. Zijp then presented two new conservation easement projects that have been on the Program's waitlist. The two properties are directly opposite one another and have been grouped together to create the Martin's Creek Conservation Easement. Steven Clark and his husband, Marty Mattox, own one of the properties; Andrew Berner and his wife Maureen Berner own the second. The two properties are in proximity to three other conservation easements, two of which are held by Buncombe County's Farmland Preservation Program, and the third being held by Southern Appalachian Highlands Conservancy. This project will offer woodland habitat and water quality protection as both properties are in a water supply watershed and have creeks running through them.

After presentations of the projects, Board Member Terri Wells asked both landowners about their interest in conservation and what led them to apply for an easement on their properties; both landowners answered. Mr. Berner said that they have four children and was asked by Board Member Ed Bulluck if they are supportive of the project, Mr. and Mrs. Berner agreed that all their children are in support of the project.

A site visit was scheduled to both properties for Board Members to happen between now and the March meeting.





Overview: Proximity to Protected Lands and Priority Ranking







