**RESOLUTION AMENDING RESOLUTION 12-08-05  
APPOINTING REPLACEMENT REVIEW OFFICERS  
TO REVIEW PLATS ON BEHALF OF BUNCOMBE COUNTY**

**WHEREAS**, pursuant to GS 47-30.2, the Buncombe County Board of Commissioners are required to appoint by resolution one or more persons as review officers to review a plat before it is recorded and certify that it meets the statutory requirements for recording; and

**WHEREAS**, the Buncombe County Board of Commissioners previously by Resolutions 97-9-14, 99-4-5, 00-10-8, 02-05-04; 03-01-01, 04-05-04, 05-08-01, 05-03-08, 07-08-11, 07-09-11, 09-11-06, 10-08-07 and 12-08-05 appointed staff members from County Planning and County Land Records as review officers; and

**WHEREAS**, the Planning Office and County Land Records have requested additional staff from the City and County be appointed as outlined on the attached Exhibit A (*which includes the original members and staff to be added*).

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners for the County of Buncombe as follows:

1. That the County employees identified in Exhibit A are hereby appointed to serve as review officers for Buncombe County.
2. That the City employees identified in Exhibit A are hereby appointed to serve as review officers for all plats or maps within the jurisdiction of the City of Asheville.
3. That this Resolution shall be recorded in the office of the Register of Deeds after adoption and the Register of Deeds Office shall index in the Grantor Index in the name of each review officer shown on Exhibit A, as may be amended.

4. That upon discontinuing employment or otherwise assuming different job responsibilities with the County of Buncombe or the City of Asheville as applicable, the duties of an appointed individual shall cease.
5. That this resolution shall be effective upon its adoption.
