RESOLUTION TO APPROVE THE BONDING OF COUNTY OFFICIALS

- WHEREAS, North Carolina General Statutes 105-349c requires the Tax Collector to provide a performance bond in an amount prescribed by this Board; and
- WHEREAS, NCGS 159-29(a) requires the Finance Officer to provide a performance bond with sufficient sureties in an amount to be fixed by this Board but not less than \$50,000; and
- WHEREAS, NCGS 159-29(b) requires any County officer, employee or agent who handles or has in his custody more than one hundred dollars (\$100) of County money at any one time to provide a performance bond in an amount determined by this Board; and
- WHEREAS, NCGS 159-29(c) authorized this Board to adopt a system of blanket faithful performance bonding as an alternative to individual bonds except for elected officials, finance officers and tax collectors; and
- WHEREAS, this Board is of the opinion that it is more efficient and economical and in the best interest of the County to have a system of blanket bonding rather than individual bonds; and
- WHEREAS, NCGS 161-4 requires the Register of Deeds to provide a performance bond with sufficient surety to be approved by this Board, in an amount of not less than \$10,000 nor more than \$50,000; and
- WHEREAS, NCGS 162-8 requires the Sheriff to provide a performance bond of any amount to be determined by this Board but not to exceed \$25,000; and
- WHEREAS, NCGS 58-72-55 requires the Clerk to the Board to record in the proceedings the names of those Commissioners who are present at the time of approval of official bonds and who voted for such approval; and
- WHEREAS, NCGS 58-72-55 further provides that any Commissioners may cause his or her written dissent to an official bond to be entered into the record of this Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners for the County of Buncombe as follows:

- 1. That this Board hereby accepts and approves bonds for public officials as follows:
 - a. Gary Clyde Roberts, Tax Collector \$100,000.00 with Selective Insurance Company of America.
 - b. Donna Brown Clark, Finance Director \$200,000.00 with Selective Insurance Company of America.
 - c. Andrew Mark Reisinger, Register of Deeds, \$50,000.00 with Selective Insurance Company.

- d. Jack Van Duncan, Sheriff, \$20,000.00 with Western Surety Company.
- e. Blanket bond covering all officers, employees and agents \$250,000.00 with Travelers Casualty and Surety.
- 2. That pursuant to NCGS 58-72-55, the Clerk is hereby instructed to record the names of all Commissioners present at this meeting who vote in favor of this resolution.
- 3. That pursuant to NCGS 58-72-55, any Commissioners who votes against this resolution may cause his or her written dissent to be entered into the record of the Board by submitting same to the Clerk within ten days of the adoption of this resolution.
- 4. That this resolution shall be effective upon its adoption.
