RESOLUTION DECLARING VARIOUS MOTOR VEHICLES SURPLUS PROPERTY
AND DONATING THE VEHICLES TO MADISON COUNTY

- WHEREAS, a request has been received from Madison County for the donation of surplus motor vehicles for its use; and
- WHEREAS, pursuant to N.C. Gen. Stat. 153A-176 and N.C. Gen. Stat. § 160A-280, the County may transfer to another governmental unit equipment that the governing board determines to be surplus, obsolete or unused; and
- WHEREAS, Madison County is a governmental unit in accordance with Article 12, Ch. 160A of North Carolina General Statutes; and
- WHEREAS, the County has seven (7) motor vehicles that County General Services and Purchasing Agent have indicated are suitable for surplus:
