WHEREAS, pursuant to N.C. Gen. Stat. §153A-344 and §78-719 of the Buncombe County Code of Ordinances, the Planning Board is charged with making a recommendation to the Board of Commissioners and to comment on whether the requested zoning change is consistent or inconsistent with the Buncombe County Comprehensive Land Use Plan and Updates and on whether the requested zoning change is reasonable and in the public interest; and

WHEREAS, the Planning Board has reviewed the application, has heard public comment, and consulted with planning staff, and, after careful review, has determined that it is in order to approve these applications and make recommendation to the Board of Commissioners for Buncombe County that the applications be approved.

Based on the facts as set forth above the Buncombe County Planning Board hereby finds and concludes as follows pertaining to the proposed amendment to the Zoning Map as set forth in the said applications as listed above:

1. said zoning change is consistent with the Buncombe County Comprehensive Land Use Plan and Updates because the Buncombe County Comprehensive Land Use Plan 2013 Update (Figure 20. Appropriate Development Types) suggests that single-family residential development be located outside of high elevation areas and flood hazard areas, and further suggests that single-family residential development be located in reasonable proximity to infrastructure (combined water/sewer service area, which, though not mapped, per the Town of Weaverville there is direct access to public water along the length of Dogwood Dr);

- 2. the majority of the subject property contains low-density single family residences; and
- 3. therefore said zoning change is reasonable and is in the public interest.


