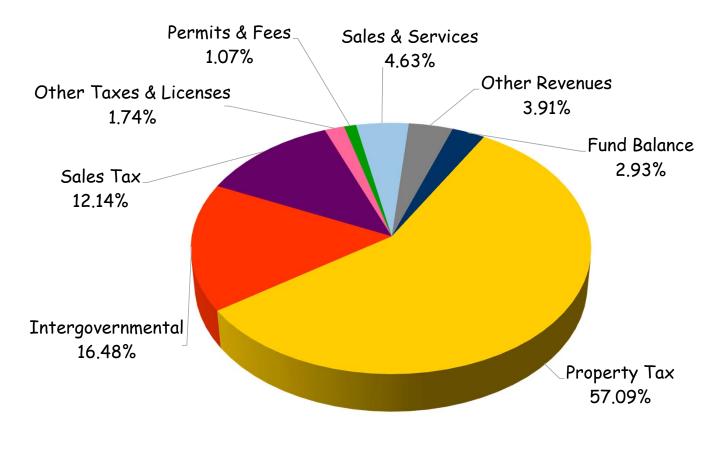

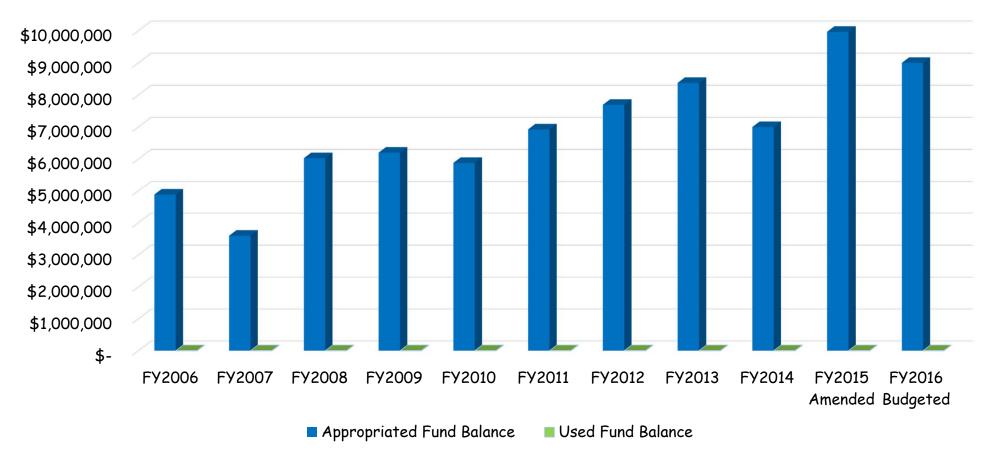

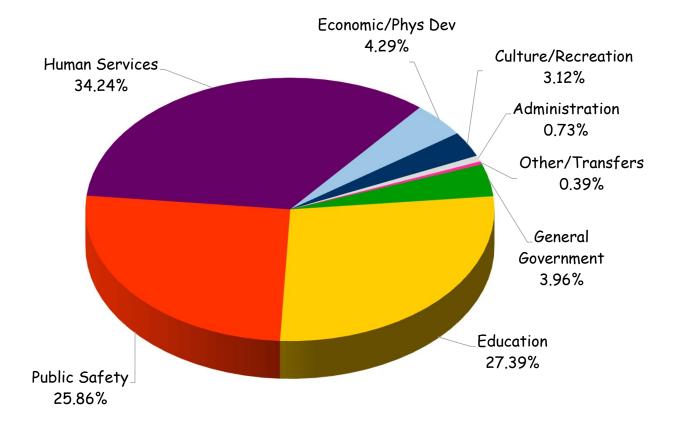
Appropriation vs. Use of Fund Balance

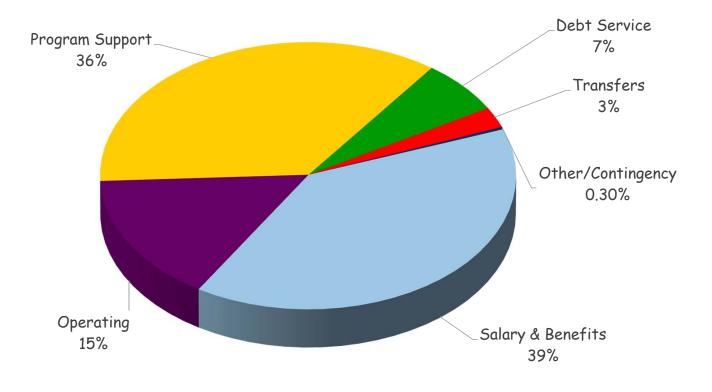

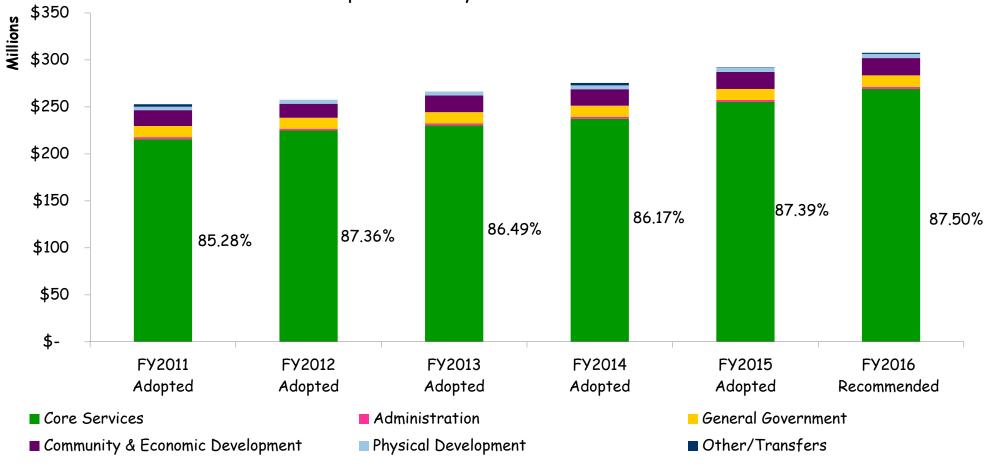

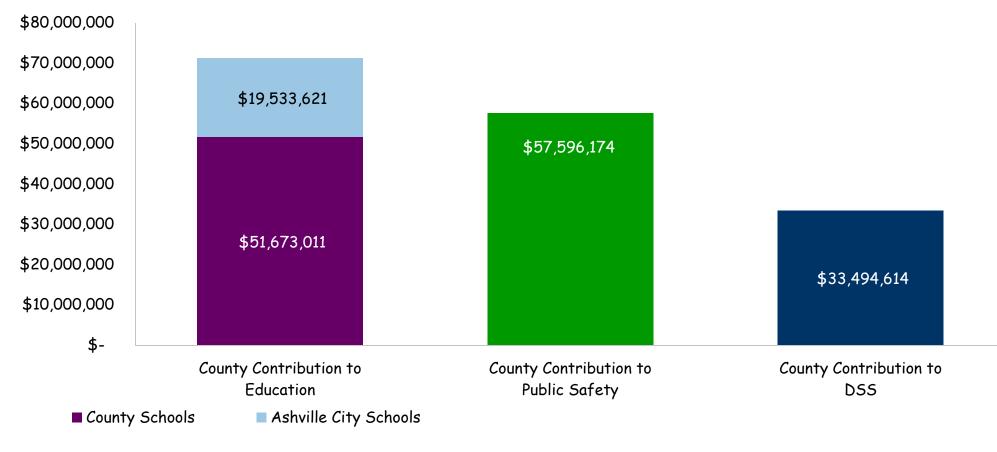

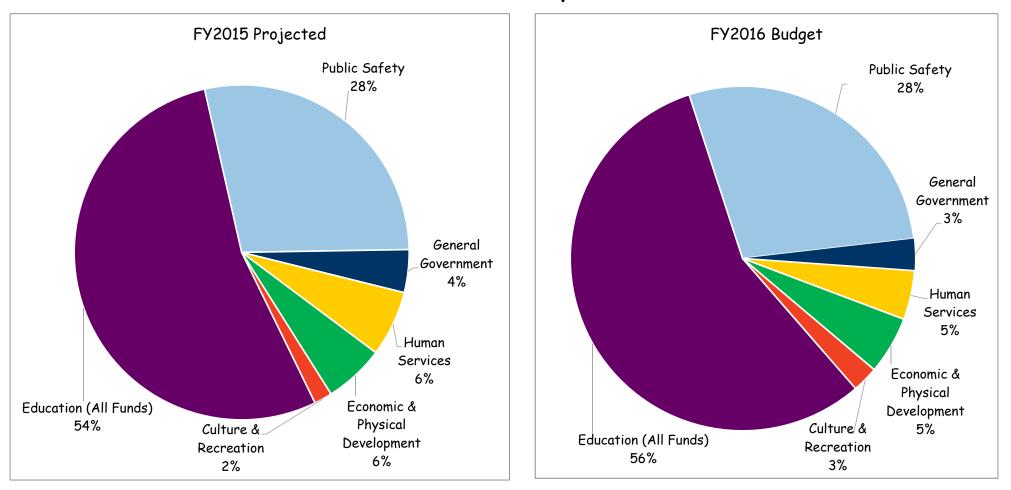

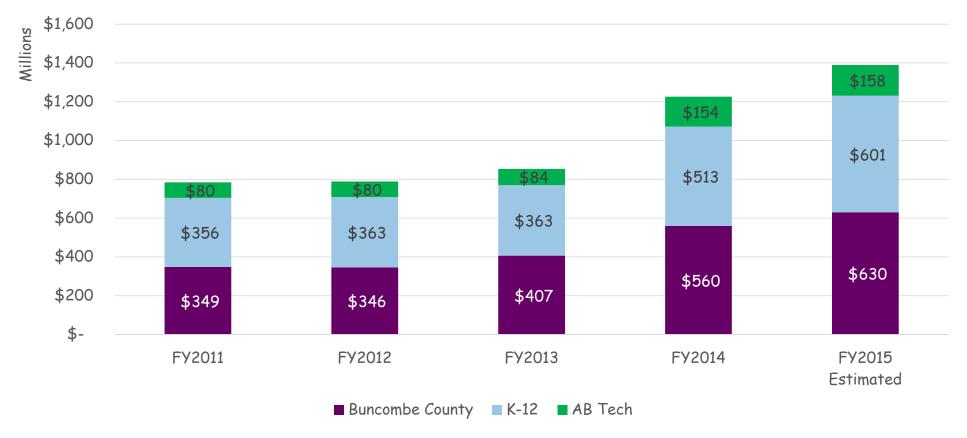
Funding Comparisons Fiscal Year 2015

Debt to Assets

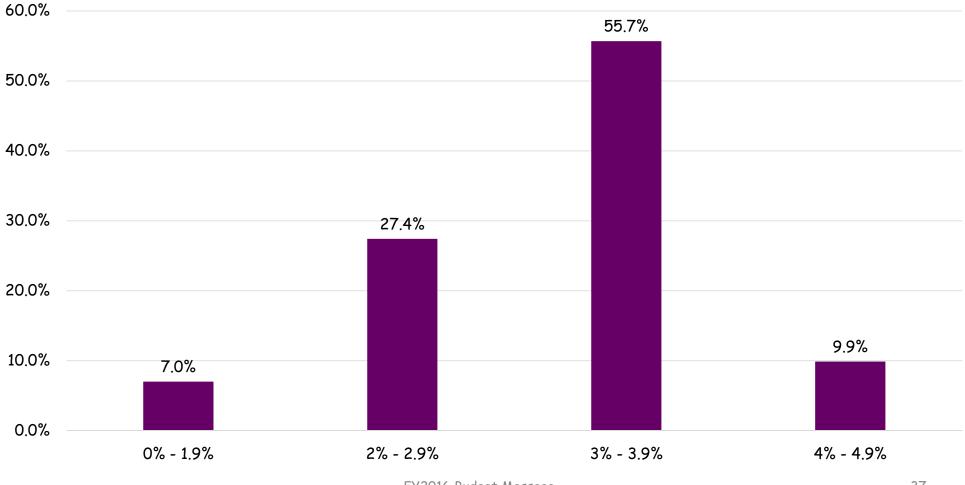
