Re: Easement Request for the Clingman Forest Greenway at Asheville Middle School

Dear Mr. Frue and Ms. Grady,

The City of Asheville would like to request that the Asheville City School Board waive their right to an appraisal of the easement area being requested, in order to facilitate the donation of the easement area near the Asheville Middle School. In return for this consideration, the City of Asheville would offer a payment of \$22,500 to pay for a future fence replacement along the easement or for any purpose deemed necessary by the School Board.

The monies needed to pay for this effort are being provided by a Federal Highways grant that is being administered through the North Carolina Department of Transportation. As a result, our actions are governed by the Uniform Act, a federal statute that guarantees the rights of property owners. I have attached the NCDOT form that is needed to waive the appraisal and donate the easement. Also included is a copy of the easement agreement with changes made pursuant to access and maps showing the easement area. The funds promised would be provided upon receipt of the fully executed easement agreement.

We ask that our offer be presented to the Asheville City School Board for their consideration. We understand the City School Board is acting as an agent for Buncombe County, who actually owns the property. We would be glad to discuss this with you further or answer any questions that may arise.
