ARTICLES OF AMENDMENT

OF

WEST BUNCOMBE VOLUNTEER FIRE DEPARTMENT, INCORPORATED

Pursuant to the General Statutes of North Carolina, the undersigned non-profit corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation.

- 1. The name of the corporation is: West Buncombe Volunteer Fire Department, Incorporated.
- 2. The Articles of Incorporation of the corporation are amended by adding the following to the Articles of the entity as follows:

"Section 7. Removal of Directors:

- a. The governing body of the local government entity that holds the contract with the highest dollar value to the West Buncombe Volunteer Fire Department, Incorporated ("Fire Department") for provision of fire services shall have the authority to remove from office up to 50% (Fifty Percent) plus one (1) member of the Board of Directors of the Fire Department pursuant to the following terms:
 - 1. Before exercising this authority, the local government entity shall notify the Fire Department, in writing, of its intent to remove up to Fifty Percent (50%) plus one (1) member of the Board of Directors of the Fire Department no more then 60 (sixty) days and no less than 14 (fourteen) days prior to a meeting to be held for such purpose. The Notice shall include the time, date and location of any such meeting together with the names of all such directors which are subject to removal by the governing body; and,
 - 2. All members of the Board of Directors together with any person residing in the West Buncombe Volunteer Fire Department, Incorporated Fire District, owning property in the West Buncombe Volunteer Fire Department, Incorporated Fire District or paying West Buncombe Volunteer Fire Department, Incorporated Fire District tax shall be entitled to speak at any meeting at which a vote removing such Board Member may occur; and,
 - 3. After such Hearing a majority vote of the governing body of the local government entity that holds the contract with the highest dollar value to the Fire Department for the provision of fire serves shall be sufficient to

effect removal of up to Fifty Percent (50%) plus one (1) member of the Board Members of the Fire Department identified in the meeting Notice.
