We process several motels in the Buncombe & Haywood County area which we take to the post office on the 19th of every month to ensure they get postmarked no later than the 20th. I am including our Postage Worksheet for the month of October which shows on the 19th that a postage stamp was placed on all of our properties and mailed including the Best Western. We use this worksheet to invoice our clients for the postage at the end of the month.

The owner of the Best Western on Tunnel Road also owns the Days Inn @ 1435 Tunnel Rd. which we also process. His report was also mailed on that day 10/19/15 and was filed on time. None of the other properties that we mailed that day have been postmarked or received late.

I have been processing these 2 properties owned by HP Patel for years (since both opened) and they have never been late.
