Description of Project

Delta House is requesting \$75,000.00 for "Delta House LEAAP for Success" after school program and summer camp. The funds will be used to provide academics and enrichment services to students in grades 3-12; hire part-time teachers, tutors, and teacher assistants to help provide the educational support and skills development the students need; operational support and an office assistant to support the program; supplies, field trips and transportation to take the students home.

The goal is to lessen the achievement gap between African American and Caucasians students in Asheville City and Buncombe County Schools. The project will provide services to 100 at-risk students in grades 3-12 who are performing below grade level in reading, math and science and are at-risk of not passing. Over 95% of the students in below poverty, live housing developments, and their parents can not afford to pay for after school care.

The students will receive services in reading, math, STEM/science, homework help, tutoring, mentoring and skills building, work in small groups and individually. The participants will have 90 minutes for homework and skills development each day.

The students will select two enrichment activities for the semester or one year. They will attend the enrichment classes twice weekly for one hour each day. The enrichment classes such as visual arts, LEAF Delta House Jazz Band, LEAF Delta House drummers, dance, health/nutrition and service learning. The students will attend the program four days per week, three hours per day and they will receive nutritious snacks and transportation home. Workshops and classes will be offered to parents and families of participating. The students will have opportunities to exhibit their work and perform in the community. They will have opportunities to take educational field trips in the city, county and within the state of North Carolina.

Delta House LEAAP for Success will provide services to 100 at-risk students in grades 3-12, living poverty or at lease 85 households in Buncombe County. These students are performing below grade level in reading, math and science and are at-risk of not passing to the next grade or graduating from high school.

At least 85% of the students served will improved their reading and math scores by 10% by the spring of 2017. At lease 90% of the students will improve their attendance in and out of school; improve their behavior and social skills.

At lease 95% of the students and their families we serve are living in poverty with incomes below \$24,000/year for a family of four. Neighboring schools have above 85% eligibility of free and reduced cost lunch, meaning their families live on income at no more than 130% of the poverty line. Delta House provide services to students and their families living in five public housing developments with an average income of less than \$6,000 per year for a family of four.

Research has shown that every year 1.2 million students drop out of school every nine seconds. Delta House "LEAAP for Success" Community Learning Centers provide a safe learning environment and rigorous academic activities and experiences helps students from dropping of school. High school dropout rates for Asheville City Schools (4.8%) and Buncombe County Schools (4.65%) are slightly higher than North Carolina overall (4.27%).

Delta House has a computer lab with 24 desktop and 30 laptops for the students to use for research, homework, desktop publishing, and skype with students around the world for globe learning and connections. Students will have opportunities to gain a basic understanding of and skills in technology and in STEM.

Through a program with United Way, community partners will be able to connect with teachers, administrators and counselors and students progress which help Delta House provide the services that the students need individually as well as small groups.

One of the barriers that we have is the students do not have the access to do their homework online because we are not connections to the schools websites for specific programs the students need for developing skills, homework, and research.

Delta House is an organization of college educated African American women committed to providing wholesome activities, programs and projects that foster the educational, health, economic, cultural, and social development for students and families with the primary focus on the economically disadvantaged and underprivileged in the minority community. Delta House was one of the first organizations in the City of Asheville and Buncombe County to provide quality after-school care focusing on education and the arts.

To provide excellence in education, cultural arts and social enrichment programs in a diverse community providing leadership through cooperation and collaboration.

Delta House LEAAP for Success program has the resources to carry out an effective, safe learning environment to help students to achieve. From 2011 to 2014, Delta House had a 21st Century Community Center Grant for \$1.3 million. We had seven city-wide community learning centers and students from Asheville City and Buncombe County Schools attended the program. We were given permission to keep all our equipment and resources to for our program.

Some of the accomplishments are the following:

. Students improved their skills in math and literacy including writing, social studies, technology/STEM.

. Students were able to display what they learned through the arts by exhibiting and performing in the community.

. 85% of students passed to the next grade level and passed the End-of-Grade Test.

. Students improved their attendance, behavior, grades and homework.

. 90% of parents cultural events and parent meetings.

A portion of the request (18%) will be used to upgrade art room located in the basement where there are problems with the moisture, space and the flooring. It is not safe for the students to create artwork in this area of the building.

We have a new kiln to fire students' clay projects but the room is too small for the students work in. The space is needed because the students should not work on carpet due to dust, allergies, and health especially in the areas where they are doing homework, using computers, and studying which is not conductive for learning.
