Description of Project

Many Buncombe County youth, particularly those from African-American households with low incomes, lack positive role models to steer them from behaviors such as substance abuse, truancy, and engaging in unprotected pre-marital sex. One Youth at a Time (OYAAT) proposes to address this problem through its Mentoring, Tutoring and Outreach Education (MTOE) project which will provide at-risk youth with life skills, academic and health education. For over 20 years, OYAAT has worked with youth by providing services designed to keep them in school and out of the criminal justice system.

OYAAT will provide trained volunteer mentors and tutors from throughout the African-American Community who can serve as positive role models to struggling youth. These mentors and tutors will help support the educational needs and goals of children in elementary, middle and high school to ensure their continued advancement in grade level and earning a high school diploma. MTOE will provide one-on-one tutoring, as well as Homework Help sessions to strengthen fundamental reading, math, science and English skills. In addition, MTOE will work with pregnant teens and teen mothers who have previously dropped-out of school to help them prepare for and take the GED High School equivalency test. OYAAT can further assist these women in acquiring job skills, finding employment and affordable housing.

Mentored youth and other adolescents in the community will receive academic, health and life skills education via community events, classroom presentations and individual tutoring. This series of events and presentations will focus on timely and relevant topics that feature lessons in STD/HIV/AIDS prevention, substance abuse prevention, the benefits of staying in school and personal goal-setting.

By combining the interpersonal effects of mentoring with the benefits of tutoring and focused outreach education, the MTOE project can meet each of its sustainability goals and turn young lives around!

How many people will this project serve?*

The MTOE Project proposes the following service levels and outcomes:

17 youth will receive at least 6 hours of mentoring and tutoring per month. Approximately 90% or more of these students will successfully be promoted to the next grade level or graduate from high school.

Each month, 150 Buncombe County youth will receive health and life skills education and/or homework assistance, and achieve one or more of the following outcomes:

- 1) Gain a better understanding of how to avoid HIV/STD transmission
- 2) Develop strategies to avoid drug use
- 3) Improve knowledge of how to make better food choices
- 4) Gain understanding of how to be a good citizen
- 5) Increase completion of school work and improve study skills

10 Buncombe County teens who are pregnant or are already mothers and no longer attending school will prepare to take the GED, learn job skills, and receive housing counseling. This will result in 25% obtaining their GED, entering community college or finding jobs.

Describe the people this project will serve.*

At least 90% of MTOE project participants are 8 to 17 year-old Buncombe County youth who are eligible for free and reduced-price meals as part of the National School Lunch Program, or whose households receive Medicaid. Most will likely live in single-parent households.

OYAAT will primarily serve residents in the high-poverty communities of Bingham Heights, Klondyke Homes, Lee Walker Heights, Leicester, Montford and Courtland Avenues, Pisgah View Apartments, West Asheville and areas south of Biltmore Avenue.

Due to the high level of need for this type of service, the MTOE Project will target members of the African American community, but will also be open to eligible children of other races and ethnic backgrounds. Historically, the project has served 76% African Americans, 12% Hispanic, and 12% Caucasian youth. Youth are referred through the school system, parents/guardians, churches and word-of-mouth throughout the target community.

What key steps will you take to achieve the results of this project?*

OYAAT will prepare volunteer mentors and tutors by 8/2016. Community partners and school counselors will refer new mentees by 8/2016. Most mentees are anticipated to require and receive weekly tutoring throughout the school year. OYAAT staff will meet bimonthly with school staff to monitor student behavior, grades and academic progress.

MTOE will provide health and life skills education to mentees and to other youth every month through classroom presentations and 6 large annual events (including the Community Healthcare Fair, Enough Is Enough Celebration, Martin Luther King Jr. Tribute to Children and Youth Celebration, and Black Church Week of Prayer for the Healing of Aids). For events with any religious content, this instruction will be separate to comply with public funding rules. Homework Help will be available to MTOE participants every Wednesday during the school year. Expecting and single teen mothers will receive GED, job, and housing counseling throughout the year.

Mentoring is proven to help youth meet positive academic, employment, and personal goals. In 1994-1995, Big Brothers Big Sisters conducted a foundational study about the positive effects of mentoring and found that, compared to youth not in a program, youth receiving mentoring services were 46% less likely to begin using illegal drugs

27% less likely to begin using alcohol

52% less likely to skip school

37% less likely to skip a class

33% less likely to hit someone

The International Academy of Education cites in its tutoring booklet (2000) that "a great deal of research evidence shows that tutoring can be very effective - and a very cost-effective way of raising achievement (Bloom, 1984; Cohen, Kulik & Kulik, 1982; Devin-Sheehan, Feldman & Allen, 1976; Levine, Glass & Meister, 1987; Rohrbeck et al., 1999; Sharpley & Sharpley, 1981; Topping & Ehly, 1998; Waberg & Haertel, 1997)."

OYAAT keeps hard copy files for each mentee in the MTOE program. OYAAT currently collects program data, such as students' attitudes, behaviors and attendance, through hard copy monthly and quarterly reports from mentors, partner schools and the Homework Help volunteer assistant. The Executive Director tracks participating student's progress and analyzes charts of program benchmark performance on a spreadsheet. OYAAT staff will develop a new mentee survey to be administered at the start and end of participation in MTOE that measures social, health and life skills outcomes, and these will be tracked in an Excel spreadsheet.

OYAAT plans to upgrade its Microsoft Office software and Internet access to improve its technological capacity. The Executive Director, who has a Bachelor of Science in Business Management and Accounting, is responsible for these new improvements in data tracking, evaluation and reporting.

OYAAT's mission is to assist City/County students in need of tutoring and/or mentoring - especially those who have demonstrated a lack of enthusiasm for education, citizenship, good health practices, or have become at-risk or critically at-risk students.

OYAAT's 2011 5-year strategic plan goals include abating truancy and behavior problems; increasing participating youth's self-esteem and responsibility to teachers/parents; and reducing school conflicts, suspensions and dropouts involving participating mentees. The MTOE Project directly addresses all these goals. The Federal Mentoring Council finds "mentoring has the potential to be a successful intervention strategy to address risk among youth and to promote positive behaviors and attitudes," including better school attendance, decreased likelihood of initiating illegal drug and alcohol use, increased social and emotional development, increased engagement in the classroom, decreased violent behavior, and better academic performance.

What expertise/accomplishments do you have that are relevant to the proposed project?*

OYAAT has served disenfranchised youth in Buncombe County for more than 20 years by providing mentoring and tutoring, health awareness education, job training and preparedness, and after-school programs.

It has become known throughout the community as the "go to" resource for troubled African American youth. It is the organization County minority residents often seek first when faced with significant behavior problems with their children.

OYAAT accepts all eligible mentees into MTOE, even ones who do not qualify for assistance from other support organizations.

OYATT has partnered with Buncombe County Schools for the past 15 years. During the past 3 years: 98% of 60 OYAAT mentees were promoted to the next grade level

 $6\ \text{out}\ \text{of}\ 10\ \text{senior}$ mentees graduated high school and went on to attend college

100% of these mentees were drug-free

100% of the single parents of mentees contributed to the success of their children

2014-15 was a difficult year for OYAAT. Although Expenses were close to budgeted projections, Revenue was less than expected due to the loss of a couple of key grant opportunities. This created a critical cash shortage that threatened program operations. Staff made cuts where possible and even paid bills out of their personal finances to insure the continued delivery of mentoring and tutoring services. At the same time, individual contributions and non-grant support from the community were higher than in years past indicating that the MTOE Project does serve an vital role in the African-American Community.

Going forward, staff and volunteers are committed to keeping this program in the community. The budgets for 2015-16 and 2016-17 have been reduced with an emphasis on program-related costs. At this time, OYAAT does not have any pending funding sources. However, they are working with contract and volunteer grantwriters to secure additional public and private funding sources.
