Description of Project

The Child and Family Protection and Self-Sufficiency Project provides free civil legal aid to help lowincome adults and children in Buncombe County. Through this project, Pisgah Legal Services (PLS) will:

* Prevent illegal/unnecessary evictions and foreclosures to help families avoid homelessness;

* Improve substandard housing conditions and maintain utility services so that families can remain in their homes;

* Secure or preserve public/subsidized housing benefits to keep the poorest families housed;

* Help victims of domestic violence, sexual assault, and child abuse escape violence and rebuild their lives;

* Secure public benefits and other resources to ensure that children and families have food, medical care, education and income.

When low-income people are able to address their basic needs, barriers to employment and high work performance are significantly reduced.

Pisgah Legal attorneys provide direct services to clients and also work to affect systemic change to improve the lives of entire groups or categories of people. For instance, we have advocated for changes to public housing policies to reduce the rent and prevent unnecessary evictions for very low-income residents.

Pisgah Legal's direct services and systemic change work plays an important role in addressing problems of poverty for thousands of Buncombe County residents and working towards poverty reduction in our community. Our efforts to help low-income families address housing problems are particularly urgent in Buncombe County right now, given our community's affordable housing crisis. Unfortunately, due to cuts in State, United Way and IOLTA funding, PLS has had to reduce the number of attorneys dedicated to housing cases, resulting in fewer families served when the need is higher than ever. PLS respectfully requests additional county funding for a homelessness prevention attorney. Additional funding would help PLS restore our capacity to provide these homelessness prevention services.

The Child and Family Protection and Self Sufficiency Project will provide legal assistance to 3,000 unduplicated households in Buncombe County. Based on our past performance, we estimate that 90% of these households will achieve the desired result, such as secure a domestic violence protective order, prevention of eviction or foreclosure, or improvement of substandard housing conditions. PLS expects that this project will improve the lives of at least 6,000 adults and children in crisis in Buncombe County (counting all of the people in each household served).

PLS offers holistic legal services to our clients, addressing an average of 2 legal issues per client, often including a housing issue. In FY 2015, 27% of our case outcomes were housing related. For low-income

families, finding and keeping safe, decent and affordable housing is one of the greatest challenges of living in poverty. Their ability to afford health insurance and basic needs are affected by the high costs of housing.

This project will serve the most vulnerable, low-income residents of Buncombe County. Most of the people served by this project will be at or below 125% of the federal poverty level (\$25,112 for a family of three). This project will serve people of all ages, races, ethnicities and geographic areas in Buncombe County. We will serve: disadvantaged children, families facing homelessness, victims of domestic violence and child abuse, people with disabilities, and vulnerable seniors.

Clients are referred to PLS by: the 211 Helpline, Buncombe County HHS, Homeward Bound, Helpmate, Our Voice, local schools, OnTrack, Mission Health System, MAHEC, WNCCHS, and many other local organizations. PLS will also receive clients through the Buncombe County Family Justice Center, once opened in 2016.

In addition, PLS conducts education and training to raise community awareness of our services and to reach potential clients.

What key steps will you take to achieve the results of this project?*

This project involves several strategies to improve the lives of low-income Buncombe County residents. These include:

- * Provision of legal advice and representation to low-income people;
- * Collaboration with local partners to work towards systemic solutions to problems of poverty; and,
- * Community education and training to help as many people as possible.

PLS provides holistic services to its clients and often addresses more than one issue for each client to create meaningful and lasting change in their lives. For example, we may help a domestic violence victim secure a protective order and child custody, as well as assist her with housing and debt issues, to make it possible for her to establish a life apart from her abuser.

This work will be ongoing throughout the funding period. Milestones will include analyzing case data quarterly to track our progress towards our goals.

Describe the evidence of success that backs this project's approach.*

What evidence of success (i.e. evidence-based research, practice model, accreditation, industry standards, and/or other framework) are you using as a basis for your project design?

Studies show that 80% of low-income people have civil legal problems and that "on average, lawyerrepresented people are more likely to win than are unrepresented people." (www.nlada.org) For people in poverty, access to justice is directly related to their most basic needs, like housing and safety. PLS found that in Buncombe County abuse victims with legal representation were 50% more likely to secure the protective orders they sought than those without legal help. An economic study showed that every dollar spent on getting a protective order for a domestic violence victim is estimated to prevent \$30.75 in societal costs.

PLS's work stabilizing housing and preventing homelessness creates tremendous savings for our community and tax payers. A 2014 independent analysis by Creative Housing Solutions showed that in Central Florida, the region spends \$31,000 a year per homeless person. In some cases, PLS prevents homelessness for a family with legal services costing \$500 to \$1,000.

Pisgah Legal Services tracks and analyzes client data (including demographics, income, referral source, etc.) and case results using Kemps database software, a sophisticated database developed specifically for legal services agencies. This database allows us to check for conflicts of interest that would prevent us from accepting a case.

PLS measures its success through: court documents (e.g. protective orders, dismissal of evictions, child custody secured); award letters related to subsidized housing, unemployment benefits, health insurance coverage and other public benefits; and attorney notes about outcomes.

With Kemps we can track a wide range of client and case data. For example, in 2014 we documented that PLS helped 14,300+ people in WNC and secured more than \$19.1 million in quantifiable benefits for our clients. Through Kemps we can also track our success rate in achieving the desired outcome for clients.

PLS trains all staff involved in client services to use Kemps effectively and consistently. Still human error does occur when entering information in the database and sometimes causes discrepancies in data. PLS works to reduce errors by developing automatic "error reports" that identify and alert staff when a possible error has occurred. In addition, managing attorneys review cases bi-annually to catch additional errors missed by the automated reports.

Pablo Averza, our database administrator, is responsible for maintenance of our Kemps database and for creating queries to pull data. PLS Managing Attorney Robin Merrell supervises Pablo and oversees our data management and analysis.

Pisgah Legal has a mission to pursue justice by providing legal assistance and advocacy to help lowincome people in WNC meet their basic needs and improve their lives. In FY 2015 we helped 7,605 people in crisis in Buncombe County with issues including housing crises, domestic violence and child abuse, securing public benefits and managing limited financial resources, protecting their consumer rights, and accessing health care.

PLS' Board of Directors adopted a new strategic plan in Spring 2015. In this plan the Board established Homelessness Prevention, Domestic Violence Prevention, and Access to Health Care and Income Supports as the top three priorities for our programs. The proposed project addresses our goals in each of these areas.

With vital support and referrals from Buncombe County, PLS will help the most vulnerable children and families in the county. This is in line with our organizational goals.

What expertise/accomplishments do you have that are relevant to the proposed project?*

PLS has provided legal aid and advocated for systemic changes to address problems of poverty in Buncombe County for 37 years. PLS has 18 staff attorneys with expertise in an array of poverty law issues and 300+ private attorneys contribute pro bono services to our clients. Volunteers' expertise and leadership increase our capacity. PLS has a network of partners, with whom we work to: provide holistic services; improve the local safety net; and work on community development issues. PLS has helped lead local efforts to reduce homelessness, expand healthcare coverage and stop domestic violence.

In the past three years, PLS has:

* Increased the number of people we serve annually despite severe state funding cuts.

* Worked with partners to develop the Buncombe County Family Justice Center set to open in 2016.

* Opened an office in the Buncombe County Courthouse to provide access to legal aid to most low-income residents facing evictions.no

* Buncombe Co. DSS - to address child abuse and provide income and other supports to low-income

families * Homeward Bound - to refer for housing and SOAR cases and to collaborate on housing programming

and obtaining resources * Housing Authority of the City of Asheville – to work collaboratively on housing policy that affects the

lowest-income tenants * Mission Health System - to refer patients and collaborate to address homelessness, DV, child abuse and

Our ability to sustain our current level of services also depends, in part, on the contributions of our volunteer lawyers and collaboration with the 28th Judicial District Bar.

PLS operates on a calendar fiscal year, which is reflected in our attached budget.
