RESOLUTION DECLARING A PORTION OF THE LEICESTER ELEMENTARY SCHOOL SURPLUS PROPERTY

WHEREAS, the Buncombe County Board of Education (hereinafter "Board") owns certain real property (hereinafter "Property") consisting of approximately 12.878 acres and having Real Estate Pin Numbers 8791-95-1380; 8791-95-0710; and 8791-95-4325;

WHEREAS, located on a portion of the Property is Leicester Elementary School;

WHEREAS, the North Carolina Department of Transportation ("DOT") would like to purchase a portion of the Property consisting of approximately 0.117 acres for a right-of-way along New Leicester Highway (the "ROW"), see map incorporated herein and attached hereto as Exhibit A;

WHEREAS, N.C. Gen. Stat. § 115C-518 provides that when, in the opinion of the Board, the use of any building site or other real property or personal property owned by the Board is unnecessary or undesirable for public schools purposes, the Board may dispose of such property according to the procedures prescribed in Article 12 of Chapter 160A of the North Carolina General Statutes; and

WHEREAS, the Board is a governmental unit of local government as defined in N.C. Gen. Stat. § 160A-27.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD AS FOLLOWS:

- 1. That the ROW be declared surplus and unnecessary for public school purposes;
- 2. That the Superintendent be authorized to offer, for appropriate consideration, the ROW to the Buncombe County Board of Commissioners, as prescribed in N.C. Gen. Stat. § 115C-518; and
- 3. That, if the Buncombe County Board of Commissioners choose not to purchase the ROW, the Superintendent is authorized to negotiate and execute a local governmental agreement pursuant to N.C. Gen. Stat. § 160A-274 with DOT and to sell to DOT the ROW and execute all necessary documents in connection with the transfer of the ROW.


