RESOLUTION AUTHORIZING BUNCOMBE COUNTY TO MAKE AN APPROPRIATION FOR ECONOMIC DEVELOPMENT PURPOSES TO THE YMI CULTURAL CENTER

WHEREAS, the YMI Cultural Center ("YMICC") is an organization that provides educational, economic, entrepreneurial and cultural programming with an emphasis on African American heritage;

WHEREAS, YMICC has requested funding from Buncombe County for Fiscal Year 2017 ("FY17") in an amount not to exceed \$40,000 to assist with its mission to continue its service as a cultural exposure forum by creating a greater awareness of the cultural heritage and a center for encouraging the contemporary culture and artistic expression vital to securing and sustaining a strong community. The mission enhances the lives of residents through comprehensive, multidisciplinary cultural arts programs in performing arts, visual arts and community outreach including the Goombay Festival;

WHEREAS, pursuant to the provisions of North Carolina General Statutes §158-7.1, a county is required to approve any such appropriation or expenditure only after holding a public hearing and such county must first publish notice of the public hearing at least 10 days before the hearing is held;

WHEREAS, this Board of Commissioners has organized the holding of a public hearing at the Board's June 21, 2016 regular meeting to discuss making this appropriation; and

WHEREAS, this Board finds that an appropriation to YMICC for FY17 will enhance employment and business prospects for Buncombe County.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Buncombe County, North Carolina, as follows:

- 1. The Board of Commissioners approves making this appropriation and spending from the County's general fund amounts to make a cash grant totaling \$_______ to YMI Cultural Center for FY17.
- 2. The County Manager, or her designees, are hereby authorized, empowered and directed to do any and all other acts and to execute any and all other documents, which they, in their discretion, deem necessary and appropriate in order to consummate the transactions contemplated by this Resolution, except that none of the above shall be authorized or empowered to do anything or execute any document which is in contravention, in any way, of the specific provisions of this Resolution.
- 3. All acts and doings of officers, employees and agents of the County, whether taken prior to, on, or after the date of this Resolution, that are in conformity with and in the

furtherance of the purposes and intents of this Resolution as described above shall be, and the same hereby are, in all respects ratified, approved and confirmed.
