Meeting Minutes Excerpts related to Penalty Waiver Request

Yesterday Spaces Penalty Waiver Request

Arik Grier, with Yesterday Spaces, was in attendance to explain the circumstances surrounding the penalty waiver request he has submitted to the BCTDA for consideration. Relevant documentation was sent to board members in advance of the meeting and was also provided in the board books. The penalty, in the amount of \$365.55, was assessed by the Buncombe County Finance Department (BCF) due to the property's failure to submit occupancy tax reports and remittances for the months of April through September 2016 on time as required by legislation.

Mr. Ellis explained that the decision made by the board is not the final decision, but it is the recommendation that will be made to the Buncombe County Commission for further and final consideration. He also explained that penalties collected are directed to county schools and are not retained by the BCTDA.

Mr. Grier introduced himself and began to review the information that the board had previously received. He shared that he recently moved to Asheville from the Boston area and is new to the local business environment. He explained that his father had been running Yesterday Spaces, which includes two properties that are available for groups to rent, which is the source of the occupancy tax. Mr. Grier's father suffered a stroke in January 2016 and, after the stroke, he was very limited in his ability to run the business. In the meantime, Mr. Grier's brother worked in an attempt to manage operations in their father's absence until Arik was able to move to Asheville to help his family. During this challenging time, Mr. Grier's father entered hospice and later passed away on October 12, 2016.

In November, Mr. Grier met with Jennifer Durrett at Buncombe County Finance where, together they worked to fully identify and resolve the occupancy tax delinquencies. At that time, Mr. Grier paid \$1,571.40 for the taxes owed for the months of April through September 2016. Ms. Durrett noted that prior to this year, Yesterday Spaces had a very good payment history with only one late payment, which was paid along with the penalty shortly after it was due. She also stated that since she met with Mr. Grier in November, all subsequent payments have been received on time.

Mr. Froeba made a motion to approve the request made by Arik Grier with Yesterday Spaces to recommend to the Buncombe County Commission that the \$365.55 penalty assessed by the Buncombe County Finance Department be waived. Mr. Luckett seconded the motion. There was no discussion and with all in favor, the motion carried 7-0.

The CVB staff will forward all related documentation to the Buncombe County Commission for further and final consideration of the penalty waiver.

Hello Joanna and the Tourism & Development Association Board,

I would like to attend your monthly meeting tomorrow at 9am to request you to consider a relief of penalties for late payment of accommodation taxes. This is for the family business called Yesterday Spaces in Leicester, and the penalties apply to the months of April through September 2016, with a total tax of \$1,571.40 (paid), and additional late penalties of \$365.55 which we still owe.

This business was founded and run by my father Michael Grier, until his stroke on January 27th of this year, which left him unable to communicate or to move much of his body. It has been a very tumultuous and difficult year for my family. After the initial weeks in the hospital, the move to rehab, then to a nursing home with rehab, we finally moved my parents from Fairview to Leicester in June to be closer to other family members for support.

My brother Aaron Grier (a full-time farmer with Gaining Ground Farm) tried to take the leadership of Yesterday Spaces, to follow through on event commitments we had with clients and keep the business afloat. This was extremely difficult for Aaron as he already works 6-7 long days a week on the farm, so I gathered all of Dad's computer files and tried to provide information and support for the business from my home in Boston where I have lived for 27 years (I grew up in Fairview, graduated from Reynolds High in 1989, and then moved away). Aaron managed the business through the end of June but was unaware of the occupancy tax requirements.

I decided with my wife that the family needed me here, and this was the time for us to move back to the Asheville area. I was able to leave my job in June and arrive in Leicester in July, to take the lead role running Yesterday Spaces and trying to keep the business from failing. During this time we continued to manage Dad's care eventually to hospice and then to his death on October 12th of this year, followed by funeral arrangements, and just loss and grief.

For many months of this year we weren't aware of the occupancy tax filing needs, and since we have learned about it, it was difficult to make the time to learn how to do it. I met with Blair Chamberlain and Krystal Frizzell to do this in person on November 10th, and I paid the taxes at that time. I appreciate the work that Tourism & Development Association is able to do to promote this whole area, and I believe we have broad shared benefits from the taxes that we businesses pay for purpose. We are also happy to be a part of growing Asheville's commerce, as we attract many people to this area to attend weddings here at Yesterday Spaces, introducing many new people to the beauty of the mountains and the excitement of the Asheville area. We also use our space and farm here to promote local agriculture, farm to table and farm to restaurant efforts.

It will be an extra burden on the business this year to pay additional penalties, and I hope you can consider relieving the penalties given our circumstances.

Hi Jonna,

Yesterday Spaces registered with us in March 2015. The establishment is seasonally closed from December through April each year. From April 2015 through January 2016, there was one payment that was postmarked 3 days after the due date (in October 2015) and assessed a penalty. The penalty was paid in November 2015.

Beginning with the 6/20/16 deadline, the County expected the occupancy tax filings to resume, but they did not. Our procedure is to send a notice to unsubmitted properties for the current month at the end of each month. If the form and payment still have not been submitted at the end of the next month, a second letter is sent. For items remaining unsubmitted past 45 to 60 days, the establishment is contacted directly. Per this procedure, we sent letters to Yesterday Spaces at the end of June 2016 and at the end of July 2016. In August, I spoke with Mrs. Grier and she informed me of their situation. She stated that Mr. Grier had always handled the filings and their son Arik had just moved to the area to help with the business. At that time, I told them about the requirements and directed them to the County's website for the forms and further information. Noticing that the forms were still unsubmitted, the County contacted Arik again in October. He made an appointment with my staff to come in and fill out all the forms and pay all tax due.

The establishment is current on their occupancy tax obligations at this time. The total penalties owed at this time are \$365.55 assessed on the returns for each month from June 2016 through October 2016.
