The county's \$1.3M contribution was funded by the prior year sale of a spec building on Jacob Holm Way to Wicked Weed






Status Updates

Capital Improvement Policy

- Establishes purpose of policy and defines capital project
- Lowers threshold from \$250,000 to \$25,000
- Establishes formal review process by Senior Leadership Team
- Clarifies adoption of the CIP by Board of Commissioners:
- Provides increased oversight of project savings
- Identifies roles and responsibilities for administration and implementation of the policy
