COUNTY MANAGER'S REPORT

• Asheville Humane Society Report

Tracey Elliott, Director of the Asheville Humane Society, gave the report that is attached to the minutes of this meeting. He thanked the Board for their investment in the shelter/adoption facility making it a model across the country. He told the Board about a new program the Society started in public housing that encourages pet safety and the grant they received from Pet Smart charities that will enable their continued work with Asheville Housing Authority.

NEW BUSINESS

• Resolution Accepting Offer to Purchase County Property Located Off Ferry Road

Mike Frue, Senior Staff Attorney, said that this 137 acre property off Ferry Road had been purchased by the County as an economic development incentive. He explained payment outlined below made by the City of Asheville at the time of purchase.

Mr. Frue said that the County had declared the property for sale and a developer had shown interest in purchasing the property for \$5,000,000. The result will be that the County will realize a net gain of approximately \$1.6 million dollars. The property included a greenway easement to the City and would be in the City of Asheville and would require a city development review and approval.

Commissioner Belcher moved to approve the resolution. Commissioner Frost seconded.

Mary Standaert questioned the details of the upset bidding process.

Jerry Rice asked that the Board give the citizens tax relief. He was not in favor of more apartments and housing that was too expensive in the County. He wanted a traffic study on the impact of this development.

Nate Pennington, Interim Planning Director, said that there was no development application on file yet and when it was ready it would be submitted to the City of Asheville since the property lies in the City of Asheville. He said that the City has conditions for development.

Mr. Frue said that if the Board accepted this bid it would be advertised in the newspaper and for 10 days any party could make a minimum upset bid of at least \$5,251,550.

Commissioner Belcher said that sale of the property would put it back on the tax rolls and make it part of the tax base. Commissioner Fryar said that the buyer would have to work with the NCDOT to improve the road into the property.

The motion passed 7-0.

• School Capital Fund Commission Recommendations

Public Schools Capital Needs Fund Project Ordinance

Tim Flora, Finance Director, gave the power point that is attached to the minutes of this meeting. He said that any project savings would come back to the School Capital Fund for other projects.

Commissioner Whitesides moved to approve the recommendation. Commissioner Frost seconded the motion.

Jerry Rice commented on the funds that were set aside for school capital needs asking that the Board look at the individual projects and schools and how much was being spent per child. He suggested that the Board have a workshop to discuss.

The motion passed 7-0.

BOARD APPOINTMENTS

Commissioner Belcher moved to appoint **Eric Robinson** to the **Juvenile Crime Prevention Council**. Commissioner Pressley seconded and the motion passed 7-0.

Commissioner Frost moved to appoint **Deborah Kania** and **Maria Hines** to the **Nursing Home Community Advisory Board**. Commissioner Pressley seconded and the motion passed 7-0.

PUBLIC COMMENT

Mary Standert was a former Council person for the Town of Montreat asked that the Commissioners investigate the disconnect that surrounded the legal addresses of the residents of Montreat. Her voter registration card says Black Mountain but her physical address is Montreat. She said that she had tried to settle the matter as a citizen and again when she was on the Town Council but had no luck. The Chairman asked staff to follow up on this issue.

Jerry Rice commented that the Commissioners talked more about dogs and cats than the children in HHS custody in a department that is highly funded. He said that the number of kids in custody is increasing and that is not considered.

Thomas VanSlamblock said he attended the Commissioners' workshop with local fire departments and he wanted the Board to considering finding more funding for these departments without increasing taxes in the county.
