#### Organization Description\*

Eliada's mission is Helping Children Succeed. We provide a cradle to career continuum of services for over 600 youth annually. In partnership with families, we meet basic needs and provide positive child and youth development programming. We also have high level intervention and prevention services for children and adolescents that focus on social and emotional well-being, life skills development, career readiness, and trauma informed treatment. Eliada is uniquely defined by:

1. Service to children for 115 years: Eliada has shown our adaptive capacity to meet the shifting needs over time.

2.Depth of experience and expertise of staff: There are staff at Eliada who have been at the agency since the 80s. Treatment staff provide clinical depth, and teaching staff provide expertise in special education and curriculum development.

3. Campus based programming: Eliada's property is a resources to all programs including access to outdoor recreation, therapeutic animals, and classroom space.

#### Shared Vision\*

What critical community problem or challenge are you hoping to improve through this project?

The Buncombe County Board of Commissioners list Opioid Addiction as one of the top Strategic Priorities for the County. There is strong data to back up this priority, and Eliada is looking at a strategic partnership with MAHEC in order to specifically meet the needs of the mothers and babies born addicted in our community. Dr. Melissa Hoffman, Trauma Surgeon at Mission Health a fellow in hospice and palliative medicine at MAHEC stated in a town hall on Jan 31st that "between 2004 and 2013, North Carolina saw a 604% increase in hospitalizations associated with drug withdrawals in newborn babies. In 2015, almost 400 babies born at Mission hospitals tested positive for substances." In this partnership, MAHEC provides medical expertise, while Eliada has the capacity to provide wrap around services such as child care, foster care, transitional living services, and job training. This project would leverage Eliada's land and build facilities for women with babies caught up in this epidemic.

Eliada and MAHEC are in the planning stages of this project. There are three main categories of activities this stage of the project requires: 1) Fundraising, 2) Program Development, 3) Construction

In order to move the project forward, a key step is hiring a Project Manager who can lead the planning and development activities. The Project Manager will consult with each organization about program needs, develop budgets and timelines, present information for timely decisions to Eliada and MAHEC, and create an overall plan for preconstruction, construction, and an occupancy plan post-construction.

While the Project Manager is creating this development plan, Eliada and MAHEC will be simultaneously building a comprehensive service model and outcomes plan. Both organizations will also be working on a comprehensive fundraising and sustainability plan to fully fund the construction activities and program implementation.

#### People Served\*

Who are the members of our community this project will serve? How many people will be served? Include demographics, including age, area median income, race, neighborhood and/or school.

While the opioid epidemic affects people across the demographic spectrum, this project is specific to women who are addicted to opioids who are either pregnant or have just given birth and their babies are born addicted. Due to their addiction, these women are at high risk of losing custody of their children. They also face issues with finding affordable housing, employment, and access to child care. They need Case Management that can help them with these issues and help them navigate both the court system and foster care system. In MAHEC's current work with these women, they have learned that about 50% are Buncombe County residents, 92% have Medicaid as their insurance payer, 85% have a trauma history, and 90% this is not their first pregnancy. Anecdotally, they have learned that the majority of them began using opioid in their early teens with a family member.

#### Partners\*

Which other organizations are you working with to reach your goals? What other local organizations provide similar services or serve similar beneficiaries, and how do you work together?

This project centers around a partnership with MAHEC. Eliada has been in conversations with MAHEC for a number of months concerning how best to leverage the capabilities of both organizations to address this slice of the opioid crisis. The current Project Cara Clinic at MAHEC works with pregnant women with addiction in getting the obstetrical services and substance use treatment they need. They have experience working with pregnant women with opioid use disorder. In conversation with Eliada, both organizations agree that in order for this model to have long-lasting impact, it needs to expand to include a residential care model which currently doesn't exist at MAHEC. Eliada has experience providing residential mental health care and transition living, along with experience in early childhood development, foster care and parent training, and workforce development. The partnership brings together the strengths of both organizations to create a model that serves the whole family.

Currently, the partnership is being stewarded by two Senior Leaders, Frank Taylor, Chief Business Development Officer at Eliada, and Jeff Heck, MD, MAHEC President and CEO. Eliada is pleased to announce that our new CEO Cindy Davis-Bryant, who was formally with Family Preservation Services of NC has a depth of experience in community-based social services, and will assist in stewarding this project.

Other project leaders include the Project Manager which this grant would fund. We are looking for an individual with previous experience in the construction industry, preferably in the development of medical complexes and residential living facilities.

Through the planning process, we plan to reach out to the community to identify other project leaders, including leaders at Mission Hospital, and leaders in community based sober-houses and treatment centers.

We also believe key project leaders should be members of County leadership who can act as advocates for this project.

Currently, there are no other funds dedicated to the project. This project is limited to the cost of hiring a part-time Project Manager to lead all planning and coordinating with MAHEC.

Out of this project, a funding plan will be developed for the construction of a medical center and residential living facility for mothers addicted to opioids and their families, along with budgets for the implementation of a mother-baby program.

Cost findings will be a key part of project planning. Each agency will examine what resources already exist at their respective organizations that can be used in this new program. For example, Eliada has already began to think through how our full-time nursing staff could also support this program, sharing personnel across programs, and saving costs across programs.

How will this project be maintained? Please describe funding sources and how you plan to sustain the project in future years.

Initial capital is needed for all construction costs. These are one-time expenses that won't be built into the program budget. Through the Cara Project, MAHEC already has a sustainable model for their part of programming, which includes obstetrical care and substance treatment. Eliada is still looking into sustainable funding sources for the residential living aspect of the program. Eliada is looking to approach the Department of Health and Human Services (DHHS) to have them adopt this model of care into their Medicaid reimbursement structure.

Eliada already has a model of providing sustainable child care services and foster care services through subsidies and DHHS reimbursement.

A sustainability plan is one of the deliverables that will result from this planning project.
