Shared Vision*

What critical community problem or challenge are you hoping to improve through this project?

People in our neighborhoods do not have access to the same things other communities have. Our students do not have computer access outside of school.

We want to encourage and inspire people by creating community based arts programs like the community choir that could eventually become a local School of the Arts.

Crime in Asheville is on the rise and the southside community has experienced excessive amounts of crime and educational disparities. Community members do not have access to computers in their homes nor within walking distance.

Or church is used by various community agencies, but still has the same equipment from 1987. New equipment would allow us to store, prepare, and serve food from a well-equipped kitchen.

As change happens in our county, community stress increases. We seek to counter that stress.

We will create the community choir, recruit 30 members, perform for area events, and track the criminal activity of the members and their families.

We will purchase 10 computers along with the software recommended by area schools and dedicate one room in our church to education.

We will host a Peace Camp engaging 75 participants where we teach anti-bullying and peaceful resolution of conflict.

We will purchase new kitchen equipment in order to store, prepare, and serve food.

New Mt Olive works with area professionals and organizations by providing resources and meeting space. Green Opportunities, Just Economics, Youth Transformed for Life (YTL), Lonnie D. Burton all utilize our church space. Historically, New Mt Olive has supported Building Bridges and Francine Delaney New School for Children.

Largely, New Mount Olive is connected to the people of the community.

We do not know of another organization that has a community choir. Asheville has not had an active community choir since around 2003. As music director, the church will contract with local tract 9 resident Terry Letman as Music Director.

The Peace Camp will engage a partnership with Asheville Police Department to help inform the curriculum and activities.

There are after school programs in our neighborhood, but they do not have access to computers for tutoring. Even students who get computers from school do not have them during the summer when its most needed.

Personnel*

Pastor Hackett will be responsible for the project. He is experienced in developing and leading community based programs. He successfully serves as the Executive Director of a local non-profit having unproved and stabilized the program. He also has a history of volunteer coordination. He works in this neighborhood and sees the challenges on a regular basis. These challenges are outside the scope of that non-profit and this church is well-positioned to meet this need.

Terry Letman - well-known and locally connected musician, producer, land-owner, and music director. With deep historic roots in Asheville, he is committed to using his skills to improve the community in Asheville by leading the choir as Music Director.

Tyrone Greenlee- locally committed community activist. well known by agencies and communities. He leads the Youth department at New Mount Olive and initiated the idea of a computer lab citing the need he has realized from work with youth and community.

Success*

Success would be Community Choir

30 community choir members (residents) who commit to advocating for Peace in Asheville and do not have any police involvement for one year.

Computer Lab

1000 hours of computerized tutoring and academic support.

Peace Camp

75 residents document a commitment to peace and anti-bullying. their criminal and bullying involvement will be tracked quarterly and documented to see if they actually maintained peace.

The new stove and refrigerator will be purchased and installed with the appropriate mechanical supports needed.

Funding*

What is your plan for finding the balance of the project budget? What is your funding timeline and what are your other sources of support?

Our source of funding is individual contributions from the congregation. In 2017, the church congregation raised \$110,000 from individuals supporting its activities. The congregation approved and committed to a budget of \$130,013 for 2018. This was before applying for County Funding. If the County were to fund this project, we would be able to use our current resources to cover the balance. We feel that our church has done a good job of supporting its previous community activities without receiving outside funding. This is an effort to ask the County to assist us with resources partnering with us to help our community - which helps the county.

Sustainability*

How will this project be maintained? Please describe funding sources and how you plan to sustain the project in future years.

New Mount Olive is debt free and has enough capital to fund all its activities for one year. The church, however, could not fund the Peace Project on its own without utilizing its reserves. When we learned about the strategic partnership fund, we determined that it was most efficient to request city funds for work that we would have already done but not as well as if we had additional resources. For example, we could afford new computers, but those computers are not for church use. They would be for the community so we seek community funding.

This funding request includes an administrative position to monitor, document and report activities of this grant.

This funding would jumpstart these activities with a surge of support, but New Mount Olive is prepared to cover the future costs of maintaining these programs as have done for all of our programs in the past.
