This mission is accomplished through a program of work focused on community development, agriculture revenue and forest health. The following are programs we manage of benefit to Buncombe County and the region; WNC Honors Awards, Journey Scholarship, WNC Agricultural Hall of Fame, WNC Regional Livestock Center and WNC Brewer's Grain. The following are agriculture groups in which WNC Communities serves as administrator; WNC Beef Cattle Commission, WNC Dairy Commission and Mountain Cattle Alliance. Other programs managed by WNC Communities that benefit the region and have dedicated funding are WNC AgOptions (NCTTFC) and Hemlock Restoration Initiative (State, Federal & County \$). WNC Honors is a 69 year old cash awards program to honor 60+ rural communities in the region for implementing best practices everything from neighbor helping neighbor to focusing on the needs of seniors, youth and families. Journey Scholarship provides funds to youth living in these rural communities to further their education. Hall of Fame recognizes pioneers who have been responsible for agricultural advancement. The Regional Livestock Center provides a local market for livestock sales. Commissions & Alliance provide educational sessions to producers to increase the value of the herd and oversee Mountain State Fair Shows to engage the next generation of farmers. Brewers Grain creates an efficient, low-cost and sustainable access-and-delivery system that acquires spent grain at the source and delivers it to dairies and small farms feeding livestock.

WNC HONORS: rural communities with ~25,000 households i.e. Avery's Creek, Big Ivy, Buckeye Cove, Cane Creek, Fairview, Leicester, Ox Creek, Sandy Mush, Shiloh & Spring Mountain. JOURNEY: Over 27 youth in Buncombe have received \$27k in scholarships. Anticipate 1-2 receive scholarships in 2019. WNC REGIONAL LIVESTOCK CENTER: Producers continue to have over \$2 million+ in their pockets with this market. In 2017 over 16,705 head were sold through the arena for ~\$12 M in revenue an estimate of 25% of the cattle coming from producers in Buncombe. BEEF CATTLE: During the current fiscal year the membership list represents 200 active members with 1/3 of those in Buncombe. DAIRY: This commission has 20 active members with a goal of organizing and increasing youth participation in the Jr. Beef Show. BREWERS GRAIN: currently providing an efficient & sustainable supply of low-cost feed of brewer's spent grain to 15+ area dairies & smaller beef cattle operations for feeding livestock.

# Partners\*

Which other organizations are you working with to reach your goals? What other local organizations provide similar services or serve similar beneficiaries, and how do you work together?

The primary partners to ensure the success of our programs are NC Department of Agriculture & Consumer Services with County Governments and Agencies located throughout the region. Specific to each program:

WNC HONORS funding comes from private industry to provide 100% of cash awards to rural communities that participate. JOURNEY: The endowment providing scholarships is with the Community Foundation of WNC. REGIONAL LIVESTOCK CENTER supported by NC Tobacco Trust, GoldenLEAF, NCDA&CS, NC Rural Center, ARC, International Paper, County Governments, Farm Bureaus, legislators and area producers. SELEX operates the facility and NCSU with NC Cooperative Extension offers educational opportunities. WNC BREWERS GRAIN program partners with New Belgium Brewing to provide the spent grain at a cost well below market with CSC handling distribution to large producers. NCSU provides research and NC Cooperative Extension agriculture agents provide appropriate criteria on mixing and feeding livestock.

# **Personnel\***

Who is responsible for the project? Briefly describe project leaders and the role each will play in the project. How do these leaders reflect the population or community that you serve?

Each program or agriculture group has a dedicated staff person assigned to facilitate committees, track progress toward implementation & document outcomes. The Executive Director is Linda Lamp with over 20 years in nonprofit management and program development. A North Carolina native, she holds a unique perspective on how to guide and encourage rural communities to develop their own grassroots solutions, as well as facilitate committee determinations for funding distributions. Agriculture programs for area producers are managed by Mike Ford. He has direct experience through his family farm located in the county. The Vice President of the Board, LT Ward is a native of Buncombe County and has spent six decades volunteering and leading efforts to improve the quality of life for those in the mountains. His role is financial

oversight of the organization, as well as managing partner of 3 LLCs created to preserve the nonprofit and enable large agriculture programs to progress.

# Success\*

WNC Communities has served the west for 69 years. In our framework as a nonprofit, we have followed a consistent model of strong board leadership with a willingness to work with numerous partners in State, County & Local governments toward common goals benefiting the people in WNC. Historically, this has led to significant pieces of infrastructure like the Ag Center, Farmer's Market, Mountain State Fair, Arboretum, Research Stations and the Regional Livestock Center. We measure results by the numbers of communities, youth and farms/farmers we support within programs that have existed for decades. Success for WNC Communities is defined from additional programs appointed by NCDA&CS to manage and distribute ~\$2.5 million dollars of TVA settlement funds into the west for agriculture, forestry and school energy projects. Opportunities like these would not be possible without the long-term support of our County Governments in the west.

#### Funding\*

What is your plan for finding the balance of the project budget? What is your funding timeline and what are your other sources of support?

The balance of the program/project budget and other sources of support come from other county funding, program fees and contract reimbursement for a portion of the staff needed during the Mountain State Fair. The funding timeline is to get requests out to counties in February and March. Specific programs are funded by the General Assembly, NCDA&CS and foundations with the funds coming in monthly during the course of the fiscal year. Contract reimbursement comes in during the month of October.

# Sustainability\*

How will this project be maintained? Please describe funding sources and how you plan to sustain the project in future years.

WNC Communities Board and Staff have worked diligently to create sustainable funding sources to underwrite the organizational budget to ensure proven rural community development, agriculture and forestry programs can continue. This has been accomplished by increasing endowment funding to supports the overall organizational budget. Another strategy has been to develop reasonable program fees to generate income. It is also critical to maintain funders interested in supporting specific programs like NC Tobacco Trust Fund underwriting the WNC AgOptions program or the State funding the Hemlock Restoration Initiative. It is important to be a viable regional nonprofit, so that when state funds are available, they can be utilized for programs in the west. What impresses state legislators is the willingness of county governments to put some skin in the game. This support has been critical to the longevity of WNC Communities and our programs.
