Strategic Priority

Coordinate a justice system that is efficient, effective, equitable and protects our public safety while holistically addressing the needs of people involved in the system



GOALS:

- Enhance the efficiency and effectiveness of the criminal justice system
- Focus on law enforcement approaches informed by best practices for serving people impacted by mental illness, addiction, homelessness, poverty and trauma
- Offer diversion and alternatives to incarceration for low-level, first time nonviolent offenders and people with mental illness and substance use disorders
- Maximize community pretrial justice solutions while prioritizing safety and offender accountability
- Support people who are incarcerated and re-entering the community from incarceration
- Focus on crime prevention and offer trauma informed support for victims of crime, including domestic violence, sexual assault and discrimination

Jailing someone who is neither results in huge costs for families and communities, including lost income, parents separated from their children, untreated mental health and substance abuse problems, a greater risk of re-offending, and wasted taxpayer dollars."

Rethinking Jails Nationally








There are **Nearly 12 million**jail admissions annually—equivalent to the populations of New York City and Los
Angeles combined and almost 19 times the annual admissions to state and federal prisons.



From 1982 to 2011, local spending on corrections—largely building and running jails—increased at least 235%. Today, \$22.2 billion is spent annually by local jurisdictions on correctional institutions.

Jails in America





Nearly 75% of sentenced offenders and those detained in jail before trial are there for nonviolent traffic, property, drug, or public order offenses.



Nationally, African Americans are jailed at almost 4x the rate of white Americans.



An estimated 14.5% of men and 31% of women admitted to jail have a serious mental illness_

rates that are four to six times higher than in the general population.


Jail in Buncombe County

Buncombe County Detention Facility can house up to 604 individuals in 13 housing units:


96 Female Beds & 508 Male Beds




Average Daily Population – May 2018

Jail Releases



- There were 11,727 releases from jail in the past year: 7,336 people
- 10% had 5 or more releases... 16% had 4 or more... and 29% had 3 or more
- Most bookings were released within 24 hours

The Grant Opportunity



- Buncombe County previously awarded \$50,000
 Innovation Fund Grant for work in Pretrial Services with domestic violence protocol
- Now invited to apply for Implementation Fund Grant of up to \$2 million plus expert technical assistance
- Goal to reduce jail population by at least 15%
- Requires system-wide collaborative and datadriven approaches
- Emphasis on protecting public safety and strengthening wellness



Areas for Improvement

- Δ Jail population growth trends
- Δ Rising numbers of women in jail
- Δ Rising numbers of substance abuse detox protocols in jail
- Δ Lengths of stay for defendants awaiting trial
- Δ Pretrial lengths of stay for non-violent charges
- Δ Number of people who cycle in out of jail multiple times
- Δ Growth in Pretrial Supervision
- Δ Higher incarceration rates/longer lengths of stay for Blacks and Hispanics
- Δ Gaps in public confidence



Jail Population Reduction Goal

Average Daily Population (ADP)	385
Excludes Contract (e.g. Federal) and State Sentenced Baseline measured November 2017-April 2018	
15% Reduction	Down by 58 to 327 ADP

- Increase Efficiencies in Case Processing
- Deflect at Arrest and Booking
- Enhance Pretrial Services
- Divert to Behavioral Health and Substance Abuse Treatment
