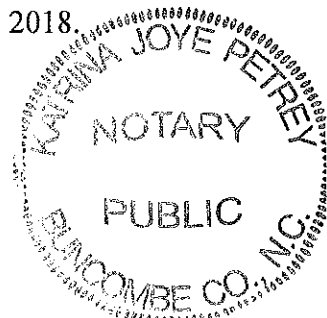

Notice is hereby given that the Board of Commissioners of Buncombe County will hold a public hearing at a regular meeting of the Board beginning at 4:30 p.m. on Tuesday, January 5, 2016, in the Commissioners' Chambers located at 200 College Street, Room 325, in downtown Asheville, North Carolina, on a proposal to provide certain economic development incentives to The Three Ring Brewing Co., LLC, a North Carolina limited liability company, d/b/a Hi-Wire Brewing (Hi-Wire). The County proposes to appropriate and spend from the County's general fund, pursuant to NCGS 158-7.1, amounts to make a certain cash grant totaling \$21,906. The purpose of this grant is to recognize the County's commitment to provide a grant to promote the expansion of Hi-Wire's current facilities in Buncombe County through its investment of \$1,620,000 in improvements, machinery and equipment and its promise to bring 12 new jobs to the County. This investment in Hi-Wire's operations further the economic interests of the County in numerous ways, including: (a) by creating a number of full-time jobs in the county with an average wage greater than the median wage in the County; (b) by enhancing the County's property tax base and increasing the County's property tax revenues; and (c) by locating in the County an advanced manufacturing facility. In addition to holding the public hearing, the Board intends to take action during the hearing in connection with these matters and may approve the making of cash grants to Hi-Wire.
