
CERTIFICATION

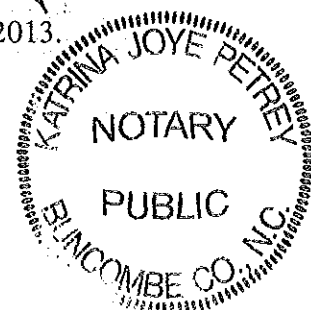
