Notice is hereby given that the Buncombe County Board of Commissioners will hold a public hearing on Tuesday, April 5, 2011 at 4:30 pm in the Commissioners' Chambers located at 30 Valley Street, Asheville, NC 28801 to consider the following amendments to Chapter 78 of the Buncombe County Code of Ordinances, The Zoning Ordinance of Buncombe County:

## **Public Safety Communications Towers**

Amend §78-580. Exemptions. to include public safety communications towers and to provide for written notice of property owners within 500 feet of the proposed facility;

Amend §78-581. *Definitions*. to add definitions for *Public safety communications tower* and *Telecommunications tower*;

Amend §78-641(a). *Permitted Use Table*. to group telecommunications towers with radio and TV towers as a category of use;

Amend §78-645. Steep Slope/High Elevation Overlay District Permitted Use Table. to group telecommunications towers with radio and TV towers as a category of use;

Amend §78-646. Protected Ridge Overlay District Permitted Use Table. by deleting Government Radio and TV towers as a category of use.
