NOTICE OF PUBLIC HEARING

Notice is hereby given that the Buncombe County Board of Commissioners will hold a public hearing on Tuesday, October 4, 2011 at 4:30 pm in the Commissioners' Chambers located at 30 Valley Street, Asheville, NC 28801 to consider the following amendments to Chapter 78 of the Buncombe County Code of Ordinances, The Zoning Ordinance of Buncombe County:

Rooming Houses and Vacation Rentals

Delete from §78-581. *Definitions*. the definitions for *Rooming house* and *Vacation rental* and replace in their entirety;

Add to §78-581. Definitions. a definition for Vacation rental complex;

Add a new section to §78-678(13). Conditional use standards. To be called Vacation Rental Complex or Rooming House. which shall set standards for the development of vacation rental complexes or rooming houses to include: frontage requirements; minimum distance between buildings; access of each dwelling unit to streets, walkways, or other common uses, and to ensure acceptable levels of emergency vehicle access; water and waste systems; parking; signage; bathrooms; and lighting;

Revise §78-641(a). Permitted use table. to delete Rooming houses and Vacation rentals and to add as separate categories Vacation rentals, Vacation rental complex, and Rooming House. Vacation rentals shall be permitted in all districts; a Vacation Rental Complex shall be conditional in R-3, NS, CS, EMP, PS, BDM, and OU; and a Rooming House shall be conditional in R-2 and EMP and permitted in R-3, NS, CS, PS, and OU;

Revise §78-645. Steep Slope/High Elevation Overlay Permitted Use Table to make Vacation rentals a permitted use in all districts; and to add as a separate category Vacation rental complex; less than 11 units which shall be conditional in R-3, NS, CS, EMP, PS, BDM, and OU; and

Revise §78-646. Protected Ridge Overlay Permitted Use Table to add Vacation rentals as a separate category which shall be permitted in all districts.
