## 1. Is your household income between \$11,490 to 45,960 for a single individual?

(\$15,510 - \$62,040 for Family of two, \$19,530 - \$78,120 for Family of three, \$23,550 - \$94,200 for Family of four)

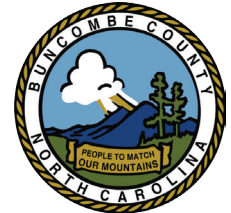
## 2. Did you experience a Qualifying Life Event? (i.e. marriage, childbirth, divorce, see reverse for complete listing)

(You must be a U.S. citizen / legal alien, NC resident & not eligible for group coverage or medicaid)

## 3. You are eligible for subsidies to pay for health insurance with ACA Health Plans!

The cost of the ACA “Benchmark” Health Plan after subsidy is...

- **\$19 per month** for a single individual earning \$11,490/yr
- **\$40 per month** for a single individual earning \$15,856/yr (\$7.62/hr)
- **\$121 per month** for a single individual earning \$22,980/yr (\$11.04/hr)
- **\$193 per month** for a single individual earning \$28,725/yr (\$13.81/hr)
- **\$247 per month** for a family of 4 with household earnings \$47,100 (\$22.64/hr)

- **\$121 per month** for a single individual earning \$22,980/yr (\$11.04/hr)
- **\$193 per month** for a single individual earning \$28,725/yr (\$13.81/hr)
- **\$247 per month** for a family of 4 with household earnings \$47,100 (\$22.64/hr)

## Do you qualify for a Special Enrollment Period under the Affordable Care Act (ACA)?

The ACA provides a Special Enrollment Period & Federal subsidies to eligible individuals that have experienced a Qualifying Life Event in the last 60 days...

- Have you experienced marriage, childbirth / adoption, divorce, or death of a spouse?
- Did you lose health coverage, Medicaid, CHIP, COBRA?
- Did your Employer drop group coverage or make it unaffordable?
- Has your income changed significantly (lose or get a job?)
- Are you a new resident of NC?
- Have you gained status as a U.S. Citizen or legal alien?
- Are you covered under the Indian Healthcare Improvement Act?
