

RESOLUTION RENAMING THE SKYLAND-BILTMORE FIRE PROTECTION SERVICE DISTRICT AS THE ASHEVILLE SUBURBAN FIRE PROTECTION SERVICE DISTRICT AND DESIGNATING SAID DISTRICT AS ASHEVILLE SUBURBAN FIRE INSURANCE DISTRICT FOR RATING PURPOSES.

WHEREAS, the County Fire Marshal has prepared updated maps of Asheville Suburban Insurance Districts for fire insurance rating purposes and has submitted said updated map to the North Carolina Department of Insurance / Office of the State Fire Marshal for their approval; and

WHEREAS, copies of said maps for Asheville Suburban Fire Protection Service District, which is an official Buncombe County Geographic Information System (GIS) map is attached herewith as Exhibit "A" ; and

WHEREAS, this Board has reviewed said map and finds that it should be approved and adopted as the official map of the Asheville Suburban Fire Protection Service District for insurance rating purposes; and

WHEREAS, pursuant to the provisions of Article 3A of chapter 69 of the General Statutes of North Carolina, the Skyland Rural Fire District was created by the County in 1961; and

WHEREAS, pursuant to the provisions of Article 16 of Chapter 153A, the Board on June 13<sup>th</sup>, 1995 created the Skyland Fire Protection Service District to serve that area of the county more commonly known as the Biltmore Estate and Biltmore Farms property and was renamed the Skyland-Biltmore Fire Protection Service District on July 1<sup>st</sup>, 1995; and

WHEREAS, in order to better describe the property for North Carolina Department of Insurance fire rating purposes, this Board deems it appropriate to rename the Skyland-Biltmore Fire Protection Service District as the Asheville Suburban Fire Protection Service District and designate said district as the Asheville Suburban Fire Insurance District.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners for the County of Buncombe as follows:

1. That the Skyland-Biltmore Fire Protection Service District be renamed the Asheville Suburban Fire Protection District and designated as the Asheville Suburban Insurance District.
2. That the Board of Commissioners for the County of Buncombe hereby designates that attached map for the Asheville Suburban Insurance District (Exhibit "A") as representative of the official fire district layer of the Buncombe County Geographic Information System (GIS) Map for the Asheville Suburban Insurance District for the purpose of fire insurance rating as proscribed by NCGS Section 153A-233.
3. That this resolution shall be effective upon its adoption.
