Project Description:

At the August 2, 2017 Board Meeting, the Board of Commissioners voted an Ordinance into place funding the Business Systems Improvement Project which accounted for the initial scope of the county's new Enterprise Resource Planning software, Workday. The initial implementation phase is now complete. This Budget Amendment closes the amount of budget spent and transfers \$422,408 of savings to the Board Contingency account to be used for later projects and \$263,173 to a transfer to the General Fund to place the budget into Information Technology's operating for ongoing maintenance and additional costs.



Funding Source:

This closes the project. The transfer to the General Fund is funded by project savings. Additional savings are being transferred to the Board of Commissioners contingency account in this fund.
