## **GOOD NEWS**

• START Program wins Innovation Award - Buncombe County HHS & FPS

Rebecca Smith, Social Work Director, explained what the START program and how it started. The award was given for quality commitment work that is being done by the department. A few members of the START team were recognized and applauded for their work.

## PRESENTATIONS

• Discussion on the Revaluation Process; and the Revaluation Fund Statute - Keith Miller, Tax Assessor

Keith Miller shared the process with Board and stated that the statute calls for an eight year cycle but the County was on a four year cycle for revaluations. Reappraisals can be required if the sales ratio is not between the target mark of 85-115%. Mr. Miller said that the county has been on an unofficial four year cycle for a while but he will present a resolution to the Board notating those guidelines.

Chairman Newman suggested that the County should not go longer than four years.

• The City of Asheville's Transit Master Plan Implementation & Buncombe County Considerations - Matt Cable, Planning & Development

Matt Cable's presentation of the PowerPoint highlighted the direction and future options of the plan. Mr. Cable is on the committee that developed the plan, which started in 2009, and he provided an update to the plan.

Commissioner Fryar expressed his concern with working with the City of Asheville and would rather focus on the County's Trailblazer system.

Chairman Newman thought the plan had some good ideas and was glad the County had someone on the committee.

Commissioner Belcher wanted to make sure that the plan was not jeopardizing the Trailblazer system.

Jerry Rice said he would be back to see the Board on the revaluation process. He stated that alcohol and tobacco is a bigger problem than opioids.
