6/5/2018	Detention Center		Catawba County deputy in Catawba County van was exiting the sally port area of the jail when the automated gate arm malfunctioned and came down along the top passenger side of van several times.
6/7/2018	Sheriff		Co driver was stopped behind other vehicle on I-26 exit 40 ramp, both waiting to make left turn onto Airport Road. When light turned green, other driver turned into far left lane that would take her back onto I-26. She states she turned on her signal to move in the next right lane to keep straight on Airport Road. Co driver was directly behind her, also making the left turn to go straight on Airport Road. Other driver was straddling the two lanes when Co driver struck left rear corner of other vehicle with front right corner of Co veh.
7/29/2018	Solid Waste		Transfer Truck Driver was at landfill unloading transfer trailer when heavy object fell out of trailer striking right rear side of customer's vehicle causing small dent and scratch to side of truck bed on fender above right rear tire.
