Budget Amendment Item: Buncombe County Detention Facility - Strategic Community Opioid Response

Description:

NC Department of Health and Human Services partnered with the Buncombe County Sheriff's Office (BCSO), allocating funding for supplemental State Opioid Response (SOR) fund through VAYA Health, for the purposes of developing a Medication Assisted Treatment (MAT) program in the Buncombe County Detention Facility. \$161,890 will come directly to Buncombe County with the balance allocated to RHA and Sunrise. BCSO has begun the development of a MAT program, which will identify opioid users in the facility, provide harm reduction strategies to each self-reporting user, and link individuals to recovery education, pre- and post-release treatment options, community-based resources and recovery pathways, and case management support. The allocated funds will provide salary and benefits, operating expenses, and service delivery costs. This request includes one grant funded, full-time, benefited Administrative Officer II position with salary grade 72. The position will terminate should grant funds not be available to cover the salary and benefits or unless agreed upon by the Board of Commissioners to fund through another source.

A presentation outlining the detention-based MAT program was made to the Commission on May 21, 2019. The Commission adopted a resolution in support of the detention MAT program on August 20, 2019.

Funding Source:

State Opioid Response funding from NC DHHS passed through by Vaya Health in the amount of \$161,890 to Buncombe County.
