### **PRESENTATIONS**

• North Carolina Senior Tar Heel Legislature

## **NEW BUSINESS**

## • Consideration of a Legal Settlement

Attorney Ron Payne stated that he had been in negotiations with the attorney of Joe Wiseman and recommended approval of a limited release settlement for his deposition and truthful testimony of \$150,000. Including this settlement, the County will have recovered approximately \$3,438,000.

Commissioner Belcher moved to approve the settlement. Commissioner Fryar seconded and the motion passed 6-0.

## • Comprehensive Facility Plan

Sybil Tate, Assistant County Manager, gave an update to the possible expansion of Detention Center but stated that the initial goal is to implement a diversion program. Ronnie Lunsford, General Services, provided a PowerPoint on the facility plan study and stated that the next steps in the process is to prepare a request for qualifications (RFQ), gather responses, negotiate a contract, and return to the Board with a final cost and contract.

Commissioner Whitesides moved to approve to allow staff to move forward with the RFQ. Commissioner Edwards seconded the motion and it passed 6-0

#### Old Zeugner Pool Building

Michael Frue, Senior Staff Attorney, informed the Board that Buncombe County Schools (BCS) would like to convert the building to a storage facility for maintenance equipment without request for new funds. Clark White, BCS Maintenance Director, stated that facility will only require electricity and that there are no immediate roof concerns.

Commissioner Belcher moved to approve the resolution and the interlocal agreement as presented. Commissioner Pressley seconded the motion and it passed 6-0.

## Budget Amendment for FY2020 Affordable Housing Services Program Applications & Allocations

Jennifer Barnette, Budget Director, explained that the budget amendment and Matt Cable, Planning Manager, provided the application process timeline.

Don Yelton suggested that the County assist with housing demolition and repurpose old trailers.

Commissioner Belcher moved to approve the recommended project proposals as presented. Commissioner Edwards seconded and the motion passed 6-0.

Chairman Newman moved to approve the budget amendment as presented. Commissioner Whitesides seconded and the motion passed 6-0.

## • Budget Amendment for School Capital Commission Recommended FY2021 Projects

Jennifer Barnette, Budget Director, explained the budget amendment.
