Buncombe County has been awarded several grants that correspond to the Woodfin Greenway Project for the design and construction of two greenway segments.

- Funding:Design \$660,000 (\$528,000 Federal Highway Administration Surface and

The Woodfin Greenway Project is part of a larger recreation destination concept funded by a Woodfin bond referendum and the Tourism Product Development Fund of the Buncombe Tourism Development Authority. The larger concept includes a whitewater wave, Silverline Park, and upfits to Woodfin Riverside Park. Recreation Services is currently managing the greenways portion of the project. Due to the complexity of the Riverside Drive segment of greenway and cost escalation due to project engagement delays, the final design estimate has been received at \$1,617,800.

Staff is requesting to reallocate the already budgeted \$632,000 of county funds for use towards the design phase of the project. The budget amendment request is for \$528,000 in additional expenditures where the funding source is the award from FHA toward the design phase of the Woodfin Greenway project.
