### **CORONAVIRUS RELIEF FUND**

- North Carolina counties are receiving funding for local governments as part of the Coronavirus Relief Fund (CRF) established under the federal CARES Act.
- Funds are administered by the State Budget and Management's Pandemic Recovery Office.
- Buncombe County's CRF allocation is \$4,499,663.



### **SUB-GRANTS**

- Because municipalities and fire districts have been critical partners in our Emergency Operations Center, Buncombe County is proposing to distribute funds as sub-grants to these entities.
- The proposed methodology uses the same method that the NC Department of Revenue uses for Sales Tax Allocation. This Ad Valorem Distribution is based on the total taxable value of each entity/district and dividing the total of all entities/districts.
- These awards are considered sub-grants subject to federal rules and regulations and will be administered via reimbursement contracts.
  Contracts will include monitoring and reporting.

### **ELIGIBLE EXPENSES**

- Expenses related to Coronavirus/COVID-19, within several broad categories:
  - Medical expenses (e.g. clinics, testing, treatment, telemedicine)
  - Public health expenses (e.g. communication, enforcement, personal protective equipment)
  - Payroll expenses (e.g. public safety or others substantially dedicated to the response)
  - Expenses to facilitate compliance with public health measures (resident feeding, sheltering, distance learning, teleworking)
  - Expenses associated with provision of economic support (e.g. small business support)
  - Other reasonably necessary expenses



#### **DETAILS**

- Funds must be used for expenditures between March 1, 2020 and December 30, 2020 for purposes that were not accounted for in the most recently approved budget as of March 27, 2020.
- Funds may not be used to reimburse for revenue loss.
- The State Pandemic Recovery Office is encouraging these funds be used prior to FEMA reimbursement, which requires a 25% match.
- Federal *Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards* promulgated by the United States Office of Management and Budget apply unless the US Treasury publishes guidance stating otherwise.

#### **NEXT STEPS**

- Municipalities and Fire Districts submit proposed plans to Buncombe County & Buncombe County submits proposed compiled plan to State
- Funds released to the County and added to the County Budget
- Project Implemented with grant coordinator, sub-grantee contracts, monitoring and reporting
