Buncombe County Aging Service Funds

- Federal Home and Community Care Block Grant (HCCBG) funds are provided to the county through the NC Department of Health and Human Services to provide supportive services to residents age 60 and older. The allocation of these funds for SFY 2021 is \$1,506,192.
- The County provides an additional \$500,000 to support aging services in Buncombe County in lie with our County Strategic Plan
- The BOCC is responsible each year to:
 - **1**. Approve the HCCBG county allocation plan
 - 2. Appoint a lead agency to oversee the allocation of HCCBG funds
 - **3.** Appoint a committee to serve as a Block Grant Advisory Committee

Buncombe County Aging Service Funds Request for Action & Next Steps

1. Approve the HCCBG and County Aging Funds Plan for SFY 2021

2. Appoint Buncombe County HHS to serve as County Lead Agency for HCCBG in SFY 2021

- Land of Sky Regional Council is highly supportive of this action, and will maintain it's partnership role as the Area Agency on Aging to distribute the HCCBG allocated funds to vendors and provide performance monitoring
- HHS will fulfill the lead agency role utilizing existing staff at an annual taxpayer savings of \$30,000
- In addition to coordinating the HCCBG allocation process, HHS will also administer county aging funds through the county's regular contract process
