Subdivision Application Review Fees (Renewal of Guarantee of Improvements)	-	\$100	Guarantees in various forms (bonds, letters of credit) can be held for years and require significant staff time to catalog, track and assist banks, insurance companies and design professionals with the renewal process	
Zoning "By Right" & Use Subject to Special Requirements (Short Term rentals, campgrounds, RV parks, rooming houses, vacation rental complexes and bed and breakfasts)	-	\$50-\$250	Short term accommodations are identified as a use and require staff resources especially if they become a code enforcement matter. These permits and fees allow staff to better track geographic location, case type and volume. Initial fees were inadvertently left out of the current fee schedule.
