Brief Summary:

The public hearing is a requirement of NCGS, but does not require any vote or action from the Board. The purpose is to allow public comment on new appropriations as well as preexisting economic development grants included in the FY2021 Budget. Each of the preexisting economic development projects have previously been approved by the board in a public hearing and are supported by economic development agreements (EDA). If new appropriations are approved as part of the FY2021 budget, contracts will be established effective July 1, 2020.
