**Subject:** Coronavirus Relief Funds

#### **Brief Summary:**

Federal Coronavirus Relief Funds were issued to Buncombe County in June 2020 in the amount of \$4,499,663. A portion of the funding (\$1,519,675) was placed in the grants fund to reimburse municipalities and fire districts as well as to fund a grants coordinator. The remainder of the funding (\$2,979,988) was placed in the General Fund to use for qualifying Buncombe County expenditures. New guidance from the state strongly recommends that the funds be kept in a special revenue fund, a designation that the Grants fund holds. The unspent balance after submitting expenditures for the period from March to June 2020 is \$197,771

Additionally, Buncombe County has received a second round of Coronavirus Relief Funds from the state in the amount of \$5,089,181 to be used for COVID-19 health-related expenditures. Approximately \$1.65 million will be offered to municipalities and fire districts as outlined in Attachment A using the same ad valorum distribution method as in the first round of funding.

These amendments complete the move of the remaining funds (\$197,771) from Round 1 for Buncombe County from the General Fund to the Grants Fund to comply with state guidance and accept the Round 2 funding into the Grants Fund for distribution and use.
