Advisory boards and commissions: covered in GS 153A-77, which states, in part, "The board of county commissioners may also appoint advisory boards, committees, councils and agencies composed of qualified and interested county residents to study, interpret and develop community support and cooperation in activities conducted by or under the authority of the board of county commissioners of said county." There is no final decision-making authority.

**Governance / Legislative boards:** these decisions are generally made by a governing body and may not be delegated. These boards are authorized to make legislative decisions typically requiring public notice and hearings.

**Quasi-Judicial boards:** have authority to make decisions regarding the application of ordinances to specific situations, and such decisions often may be appealed to a higher authority or the courts. These decisions require specific findings.

The recommendation is to priortize interviews for the Governance and Quasi-Judicial Boards and Commissions, unless it is a reappointment. For the Advisory Boards and Commissions, the Board or Commission can interview or screen applications and make recommendations.
