Subject: FY 21 Affordable Housing Services Program Applications, Allocations, and Associated

Budget Amendments

Brief Summary:

The Board of Commissioners annually budgets funds to support affordable housing projects through the Affordable Housing Services Program (AHSP). Available funds include:

| \$1,811,845 | FY 2021 AHSP budgeted funds |

On August 9, 2020 notice of a request for affordable housing project proposals was advertised. Eleven (11) of the 14 applications received were determined eligible. On October 6, 2020, the Affordable Housing Committee reviewed project proposals and recommends the following allocations which would impact 892 units/households:

| \$40,000 | Buncombe County Employee Housing Assistance Benefit Program Loans (HR) |
| \$1,293,811 | Total Allocations |

The recommended loan for Jasper Apartments represents the third allocation by the Board of local funds to the project. The Committee recommends the two (2) loans be combined into a single FY 2021 AHSP loan. Staff recommends the HOME allocation be combined with the AHSP loan using local funds and to the exclusion of HOME program income. Total allocations include:

The Affordable Housing Committee continues to review and consider eligible applications and potential affordable housing activities to which the balance of available FY 21 AHSP funds (\$673,297) can be applied.

Recommended Motion & Requested Action:

The Board of Commissioners approve the recommended: FY 21 Affordable Housing Services Program project proposals and allocations, consolidation of Jasper Apartment allocations under singular FY 21 AHSP program guidance, and associated budget amendments.
