The Chairman called the meeting to order at 3:06 p.m.

During the meeting, the Board and staff will review and discuss agenda items and receive staff updates with discussions as noted:

Swear In of New Commission Members. The Honorable Calvin Hill, Chief District Court Judge, performed the swearing-in ceremony for newly-elected Commissioners, Brownie Newman, Jasmine Beach-Ferrara, Parker Sloan and Terri Wells.

Staff Updates:

COVID-19 Discussion. Stacie Saunders, Public Health Director, and Fletcher Tove, Preparedness & Security Officer, provided information related to the Thanksgiving holiday cases, vaccine distribution, and metric data (3 categories coded red). NC Executive Order 180 requirements were reviewed and updates of enforcement violations were discussed.

COVID Violations and Enforcement. Michael Frue, Senior Staff Attorney, requested and the Board agreed to add this item to the evening's regular meeting agenda under New Business to discuss updating the fire code ordinance.

Input on Duke Energy's Integrated Resource Plan (IRP). Jeremiah LeRoy, Sustainability, explained the IRP. The goal would be to provide input to the plan that recognizes the County's interest. A "petition to intervene" will be developed and submitted that identifies the County's strategy of a 100% renewable roadmap.

Racial Equity Plan Check-In. DK Wesley, Rachael Nygaard, Lynn Smith, Zo Mpofu of the Equity & Inclusion Team explained the policy direction of equity as a value, introduction of the workgroup, and the planning process. In the timeline, there are community and foundational goals defined.

Local Government Investment Pool (LGIP). Don Warn, Finance Director, discussed the development of the LGIP for the County. The LGIP was defined as a cooperative investment product designed primarily for the investment of short-term funds of participating jurisdictions that invest the cash in securities allowed under the state's laws regarding government investments. The next steps in the development of the LGIP will be to enter into an interlocal agreement with Wake County as a sponsoring organization, finalize trust documents, and contract with service providers.
