PUBLIC HEARINGS

Emergency Paid Sick Leave

Sharon Burke, Human Resources Director, explained the data for the temporary policy recommendation to extend Emergency Sick Leave and COVID Quarantine Leave Policy for the employees who did not use this benefit prior to December 31, 2020 and to provide designated Buncombe County employee's salary continuation, if quarantined, due to a suspected workplace COVID-19 exposure. This policy would be in effect, retroactively, as of January 1, 2021.

The Chairman opened the hearing at 5:21 p.m.

Nigel Smith expressed his support for approval of the policy.

The hearing was closed at 5:22 p.m.

Commissioner Wells moved to approve the ordinance that includes the temporary policy and to provide discretion to the HR Director to grant Quarantine Leave for positions not listed in the policy. Commissioner Edwards seconded the motion and it passed 7-0.

NEW BUSINESS

• FY2022 Cost of Living Adjustment

Jennifer Barnette, Budget Director, explained that the Board of Commissioners directed staff to remove the budgeted funds for the expected COLA for FY21. Staff recommended to pay for COLA with FY21 lapsed salary and include future COLA consideration during the budget process.

Chairman Newman moved to approve the COLA of 1.45% for 15 months starting in April 2021 and not apply the COLA to the Commissioners' salary. Commissioner Beach-Ferrara seconded and the motion passed 7-0.

• Budget Amendment for Emergency Rental Assistance

Jennifer Barnette, Budget Director, explained the budget amendment.

Commissioner Sloan moved to approve the four grant-funded positions. Commissioner Pressley seconded and the motion passed 7-0.

Vice Chair Whitesides moved to approve the budget amendment as presented. Commissioner Edwards seconded and the motion passed 7-0.
