SUBJECT: Approval of January 2021 Tax Collection Report

BRIEF SUMMARY:

NCGS 105-350 requires the Tax Collector to submit a report showing the amount of taxes collected.

As of January 31, 2021, the total levy billed for fiscal year 2021 is 96.07% collected, as compared to 96.35% for fiscal year 2020. At our rate of collections, we expect to meet the Current Year Ad Valorem budgeted amount.

The personal property category is made up of both Business Personal Property (BPP) and Individual Personal Property (IPP). The BPP percentage collected of 95.75% is nearly one percent below the same time last year. The percentage collected for IPP of 62.45% is significantly below the collected percentage of 73.08% as of the same time last year, due to the significant amount of MV registration gap tax outstanding.
