<b>Grant Name:</b>	2020 Census - Community Center Kiosks

**Description:**

In March 2020, the Dogwood Health Trust (DHT) awarded \$21,600 to install internet kiosks in community centers across Buncombe County in order to increase Census participation. The project is complete and resulted in \$3,488.82 in remaining budget.

This amendment realigns the original budget to actual spending by type and reduces the total budget by the current savings (\$3,488). These funds will be budgeted in a new grant, which uses the repurposed savings.

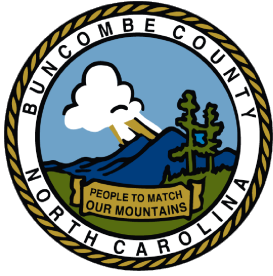

<b>Grant Name:</b>	Census Incentives Grant

**Description:**  
 The Dogwood Health Trust (DHT) supported efforts to increase Census counts by incentivizing Buncombe County to increase its response rate. Buncombe County established this grant and \$10,000 budget on August 4, 2020. Since establishing the grant, DHT increased the incentives associated with the grant by \$4,000, and the remaining award is \$13,240.  
  
 This amendment reduces the budget by the current budget savings (\$9,240). These savings and the additional \$4,000 award will be budgeted in a new grant, which uses the repurposed savings.

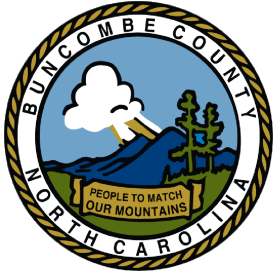

<b>Grant Name:</b>	DHT Census Grants Savings

**Description:**  
 Buncombe County received two grants from the Dogwood Health Trust (DHT) to increase Census participation. As a result of COVID-19, the scope of the project was changed and grant funds were not completely expended. DHT confirmed unused funds will not be returned to DHT and the funds can be used in line with DHT's overall priorities and purpose.  
  
 Buncombe County staff are exploring strategies for utilizing the funds for expanding internet access at public library locations to allow patrons to access outdoor/parking lot internet access. This grant consolidates the savings from two census-related grants to establish a budget for the new project.
