Subject: FY2022 Budget and Economic Development Appropriations –

Brief Summary:

A public hearing is required after the budget is presented to the board. The general statutes also require a public hearing for any proposed appropriation or expenditure for economic development purposes prior to approval. This hearing is allowable as part of the public hearing on the annual budget. The purpose is to allow public comment on any budget appropriations, including requested appropriations for strategic partnership grants as recommended during this year's Strategic Partnerships grant award process, and requested appropriations for economic development partners included in the proposed budget. Contracts for requested appropriations of Strategic Partnership grants and Economic Development partners will be established in July. The requested economic development hearings are as follows.
