3/14/2018	Sheriff	Isaac McLemore	Law enforcement retiree represented by Gene Leicht in back claim from motor vehicle accident (MVA). MVA exacerbated civil deputy's already bad back. Maximum Med Improvement (MMI) 7/13/20 with 30% PPD to back = \$54,055.80. Settled at Voluntary mediation 8/20/20 for \$120,000.
5/16/2018	Tax Collections	Sherri Hines	59 yo patrol deputy slipped and fell on wet porch steps suffering injuries. Employee treated with Dr. off and on for the pain up to 6/26/20, complaining of pain and swelling. Dr. indicated these complaints were not related to her initial injury 5/16/18 - confirmed previous Maximum Medical Improvement and 0% disability. Therefore, we denied her current condition. Employee hired Oxner & Permar to represent her in her wc claim. A Request for Hearing was filed. Settled at mandatory mediation 10/21/20 for \$7,000 + mediator's fee + costs. Claimant retired 2/1/21.
1/27/2020	Detention Center	Todd Heuermann	Unrepresented workers comp claimant. Attacked by inmate 1/27/20. Maximum Medical Improvement 9/10/20 - 4% Permanent Partial Disability to right shoulder = \$5431.30. Claimant settled at \$10,000 to include a resignation and
10/12/2017	Sheriff	Randy McMahan, et al	Excessive use of force claim involving claimant, his wife and their minor son. Settled at 12/9/20 mediation for \$167,500 + mediator's fee.
9/11/2020	Social Services	Patricia Haney	63 yo Social Worker represented by Charles Collier, III in claim after her vehicle hatchback (latch) fell and hit her while removing items after arriving home. County denied workers comp claim. Settled at mediation 2/18/21 for \$16,125 + mediator's fees.
9/12/2017	County Manager	David Oppenheimer	Copyright infringement. County displayed copyrighted photo without permission on its website 9/12/17-10/22/19. Initial demand was \$12,000.
